## RESOLUTION NO.

A RESOLUTION AUTHORIZING THE MAYOR AND CITY CLERK TO ENTER INTO AN AGREEMENT WITH THE ARKANSAS DEPARTMENT OF TRANSPORTATION TO DONATE PROPERTY FOR THE INTERSTATE 30 AND INTERSTATE 40 WIDENING AND RECONSTRUCTION PROJECT; AND FOR OTHER PURPOSES.

WHEREAS, the Arkansas Department of Transportation ("ArDOT") has identified the need for safety, mobility, and modernization improvements to Interstate 30 from Interstate 530 to Interstate 40 and to Interstate 40 from Interstate 30 to Highway 67 (the "Project"); and

WHEREAS, ArDOT has identified certain property owned by the City of North Little Rock ("City") that is necessary for completion of the Project (see map attached hereto as Exhibit A); and

WHEREAS, the Project will enhance and contribute to the safety and quality of life for the residents of the City and it is in the best interest of the City to donate the property to ArDOT to facilitate completion of the Project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the Mayor and City Clerk are hereby authorized to enter into an agreement for donation of real estate for highway purposes with the Arkansas Department of Transportation (see Agreement attached hereto as Exhibit B) and to execute any other documents necessary to effectuate the donation of the property to ArDOT.

SECTION 2: That this Resolution shall be in full force and effect from and after its passage and approval.


