

ORDINANCE NO. ____

AN ORDINANCE AMENDING THE 2020 QUOTA ORDINANCE (ORDINANCE NO. 9197) FOR THE NORTH LITTLE ROCK FINANCE DEPARTMENT AND THE NORTH LITTLE ROCK VEHICLE MAINTENANCE DEPARTMENT; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, the City Council is responsible for establishing the number of employees in each department, and on December 23, 2019, adopted Ordinance No. 9197 establishing job classifications and numbers of employees for each department of the City of North Little Rock for 2020 (amended by Ordinance No. 9205, adopted January 27, 2020; Ordinance No. 9215, adopted February 24, 2020; Ordinance No. 9256, adopted June 8, 2020; Ordinance No. 9273, adopted August 24, 2020); and

WHEREAS, by enacting an ordinance listing the numbers of employees in each job classification in each department for 2020, the City Council will be in a better position to monitor and evaluate the numbers of employees necessary to the operation of each city department; and

WHEREAS, it has been determined by the City Council that it is necessary from time to time to amend such ordinance to add or delete positions, to correct errors, reorganize departments, reclassify positions, re-title positions, and for other purposes, to increase the efficient operation of the City of North Little Rock; and

WHEREAS, the Finance Department requests one (1) position to be deleted and one (1) position to be added; and

WHEREAS, the Vehicle Maintenance Department requests one (1) position be added.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That Section 14 of Ordinance No. 9197 is hereby amended as follows:

SECTION 14: That the Finance Department shall consist of fourteen (14) full-time employees as follows:

- Director of Finance and Budget, NEG - 1
- Accountant, Senior, NG- 1
- Accounting Clerk III, F06A - 1
- Accounting Clerk, Senior, F07A – 5 -1= 4, delete one position**
- Accountant, F11-1, add one position**
- Assistant Finance Director, NG – 1

Assistant Payroll Specialist, F08 –1
Payroll Manager, NEG – 1
Customer Service Clerk, F05B - 1
Payroll Specialist, F10 – 1
Comptroller, NG – 1

The position will be deleted after one Accounting Clerk Senior position becomes vacant.

SECTION 2: That Section 29 of Ordinance No. 9197 is hereby amended as follows:

SECTION 29: That the Vehicle Maintenance Department shall consist of **thirteen fourteen** (~~13~~ **14**) full-time employees as follows:

Director, NEG - 1
Mechanic/Shop Foreman, Grade P13 – 2
Mechanic, P11 – 4 + 1= 5, add one position
Office Assistant Senior/Fleet Services Support, F05A –1
Service Bay Worker, P08 –2
Sr. Service Bay Worker, P09 – 1
Welder, P11 – 1
Lead Welder, P12 – 1

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.

SECTION 4: That the provisions of this ordinance are hereby declared to be severable and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 5: That the City Council has determined that the interests of the City and City employees can best be served by the adoption of this ordinance; THEREFORE, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect from and after its passage and approval.
