**A RESOLUTION ACCEPTING THE BID OF AND AUTHORIZING THE MAYOR AND CITY CLERK TO ENTER INTO A CONTRACT WITH GENE SUMMERS CONSTRUCTION, INC. FOR 9TH STREET IMPROVEMENTS - FROM G STREET TO I STREET, IN THE AMOUNT OF \$322,470.00; AND FOR OTHER PURPOSES.**

WHEREAS, the City of North Little Rock has advertised for bids for a Community Development Block Grant (CDBG) Project, 9th Street Improvements from G Street to I Street; and

WHEREAS, the low bidder meeting bid requirements for the project was Gene Summers Construction, Inc. with a bid for the project of \$322,470.00 (see bid information attached hereto as Exhibit "A"); and

WHEREAS, \$308,422.39 of the contract amount will come from FY2018 and FY2019 Community Development Block Grant (CDBG) Funds and \$14,047.61 of the contract amount will come from Ward II 2017 Sales Tax Capital Improvement Funds.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the low bid of Gene Summers Construction, Inc. for 9th Street Improvements – from G Street to I Street, in the amount of \$322,470.00 is hereby accepted.

SECTION 2: That \$308,422.39 of the contract amount will come from FY2018 and FY2019 Community Development Block Grant (CDBG) Funds and \$14,047.61 of the contract amount will come from Ward II 2017 Sales Tax Capital Improvement Funds.

SECTION 3: That the Mayor and City Clerk are hereby authorized to execute all documents necessary to effect the completion of the herein stated project, with all contracts/agreements to be reviewed and approved by the City Attorney prior to execution.

SECTION 4: That this Resolution shall be in full force and effect from and after its passage and approval.

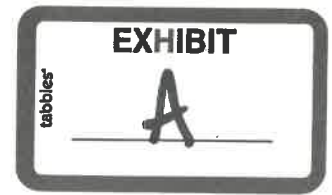
