

City Beautiful of North Little Rock Beautification Grant Guidelines

Do you have a really beautiful idea for your neighborhood?

Do you know of an area that needs landscaping, or would be perfect for a garden?

Here's what you can do:

- You can do what other residents do, by getting plants and materials in exchange for your volunteer planting and maintenance efforts.
- Projects must be within the city limits of North Little Rock and in a highly visible public area.
- Schools, non-profits, and other neighborhood organizations that wish to help foster community pride in North Little Rock are eligible.

Basic Philosophy

City Beautiful of North Little Rock provides matching grant support to nonprofit organizations, neighborhood associations, schools and other community organizations that wish to help foster community pride in North Little Rock through beautification or landscaping.

Grant Range

Grants range from \$100 - \$2000

However, on a project-by-project basis, some grants may be funded at a higher level. Funding is to be matched by volunteer efforts and/or matching cash donations.

Grant Limitation

Projects must be on City of North Little Rock property, North Little Rock School District property, North Little Rock Housing Authority property, North Little Rock public right-of-way, or property leased or an easement by the City. Please be advised that Federal and State Constitutions restrict the City's ability to award grants for the improvement of church property and religious schools.

Application Procedures

Applications for grants may be obtained from Neighborhood Services at 3427 North Magnolia Street, by calling the office at (501) 791-8500 or online at www.northlr.org. The Grant Review Committee meets on the third Monday of each month at 6:00 p.m. to review applications. Meeting location is 4601 Fairway Avenue, North Little Rock, AR 72116. Grant applications should be turned in no later than 7 days prior to each monthly meeting. Turn completed applications with all necessary documentation to: Office of Neighborhood Services, 3427 North Magnolia, North Little Rock, AR 72116.

Areas of Interest

Primary areas of interest are highly visible sites to be enjoyed by the public, which include:

- Theme, cultural or educational gardens,
- Plants and materials,
- Life Lab projects that teach science, nutrition and horticulture.

Matching Grant Information

As an incentive to foster a greater sense of pride in the community, City Beautiful of North Little Rock provides grant awards for beautification projects that:

- Are highly visible to the general public,
- Provide educational enrichment opportunities for residents and visitors,
- Are reflective of a specific theme, such as cultural heritage gardens, rose gardens and Victorian gardens,
- Promote and preserve the cultural heritage of our community,
- Promote tree planing and preservation,
- Promote stewardship of the environment,
- Enlist community participation,
- Secure long-term maintenance assurances.

Examples of beautification projects eligible for funding include:

- Landscaping projects, including plants, trees, containers, walkways, benches, tables, fountains, decorative structures and irrigation systems.
- Life Lab projects that teach science, nutrition and the benefits of horticulture through active participation and curriculum.

Examples of ineligible projects include:

- Requests from individual property owners on their own behalf.
- Tree removal,
- Play equipment,
- Overhead costs (Office supplies, phone bills, etc.).

APPLICATION INSTRUCTIONS:

1. Fill in all blanks completely.
2. You must provide a tax identification number if applicable.
3. All attachments must be clearly labeled with the organization's name, project, date and location. All photographs must so be labeled.
4. All blueprints and site maps must show north direction if possible.
5. Streets and structures must be shown and labeled.
6. All documents must fit in a letter sized folder.


Standard Conditions
