

RESOLUTION NO. _____

A RESOLUTION REAPPOINTING COMMISSIONERS OF THE NORTH CEDAR STREET IMPROVEMENT DISTRICT NO. 32 OF NORTH LITTLE ROCK, ARKANSAS; AND FOR OTHER PURPOSES.

WHEREAS, the City of North Little Rock established the North Cedar Street Improvement District No. 32 of North Little Rock, Arkansas (the "District") on December 12, 2012, through the adoption of Ordinance No. 8490; and

WHEREAS, pursuant to ACA 14-88-301(a)(1)(B), the Commissioners of the District have staggered terms as follows commencing January 1, 2013: Andrew J. Collins, III – Six years; Andrew J. Collins, Jr. - Four years; Somers A. Collins - Two years; and

WHEREAS, record owners of real property within the area of the District have petitioned to extend the terms of the Commissioners, said petition being attached hereto as Exhibit "A"; and

WHEREAS, City Council is authorized, pursuant to Ark. Code Ann. § 14-88-301, as well as other statutory and common law authority, to reappoint commissioners serving the District.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That Somers A. Collins is hereby reappointed as a Commissioner of the District for a period of six (6) years from and after December 31, 2014, and that Andrew J. Collins, Jr. is hereby reappointed as a Commissioner of the District for a period of six (6) years from and after December 31, 2016.

SECTION 2: That this Resolution shall be in full force and effect from and after its passage and approval.





**PETITION FOR REAPPOINTMENT OF COMMISSIONERS OF
MUNICIPAL IMPROVEMENT DISTRICT**

TO THE CITY COUNCIL
FOR THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

Whereas, the North Cedar Street Improvement District No. 32 of North Little Rock, Arkansas (the "District") was organized by the City of North Little Rock as a municipal improvement district under the authority of Chapter 88 of Title 14, Subtitle 5 of the Arkansas Code of 1987 Annotated pursuant to City of North Little Rock Ordinance Number 8490, entered December 12, 2012; and

Whereas, Pursuant to ACA 14-88-301(a)(1)(B), the Commissioners of the District have staggered terms as follows commencing January 1, 2013: Andrew J. Collins, III – Six years; Andrew J. Collins, Jr. - Four years; Somers A. Collins - Two years; and

Whereas, each of Andrew J. Collins, Jr., and Somers A. Collins continue to meet all qualifications as commissioners for the District, who are individuals of integrity and good business ability and respectively control and own an entity which holds legal title to a majority of assessed value of the lands in the District; and

Whereas, the Petitioners desire that the term of the Commissioner, Somers A. Collins, be extended for a period of six (6) years from December 31, 2014, and the term of the Commissioner, Andrew J. Collins, Jr., be extended for a period of six (6) years from December

31, 2016.


Now, therefore, the undersigned ("Petitioners"), Andrew J. Collins, III, Andrew J. Collins, Jr. and Somers A. Collins, being existing Commissioners of the District, do hereby petition the City Council for the City of North Little Rock, Arkansas, under Arkansas Code of 1987 Annotated Section 14-88-303, to reappoint Somers A. Collins as a Commissioner of the District and extend her term as Commissioner for a period of six (6) years from and after December 31, 2014, and to reappoint Andrew J. Collins, Jr., as a Commissioner of the District and extend his term as Commissioner for a period of six (6) years from and after December 31, 2016.

The Petitioners have executed this Petition effective January 3, 2017.
