WHEREAS, the City of North Little Rock established the City of North Little Rock Municipal Multipurpose Improvement District No. 37 - Faulkner Crossing ("Improvement District No. 37" or "District"); and

WHEREAS, the municipal board of improvement for the District shall file a report of its plan of improvement and estimated costs with the City of North Little Rock; and

WHEREAS, the Commissioners of the District have petitioned for the appointment of Assessors of the District, said petition being attached hereto as Exhibit "A"; and

WHEREAS, City Council is authorized, pursuant to Ark. Code Ann. § 14-88-201, to appoint the assessors for the District.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That Rachel Grist, Jennifer Owens and Dominica Williams are hereby appointed as Assessors of City of North Little Rock Municipal Multipurpose Improvement District No. 37 - Faulkner Crossing.

**PETITION FOR APPOINTMENT OF ASSESSORS OF
MUNICIPAL IMPROVEMENT DISTRICT**

TO THE CITY COUNCIL
FOR THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

Whereas, a public hearing for adoption of the City of North Little Rock Municipal Multipurpose Improvement District No. 37 – Faulkner Crossing (the “District”) was heard by the City of North Little Rock as a municipal improvement district under the authority of Chapter 88 of Title 14, Subtitle 11 of the Arkansas Code of 1987 Annotated and the City of North Little Rock has scheduled consideration of the Ordinance(the “Enabling Ordinance”) to form the District at its meeting set for December 12, 2016; and

Whereas, the municipal board of improvement for the District intends to formally adopt a plan of improvement and ascertain the cost of the improvements for the District and shall file a report of such plan with the City of North Little Rock (the “Plan”) promptly upon the adoption of the Enabling Ordinance; and

Whereas, A.C.A. §14-90-201 provides that, once the Plan is filed, the city council shall appoint three (3) electors of the city who shall constitute a board of assessment to review the benefits to be received by each lot or block or other subdivision of land with the improvement district by reason of the proposed local improvement; and

Now, Therefore, the undersigned (“Petitioners”), Mr. Michael Hansberry, Mr. Forrest Brimley, Mrs. Sandra Davis, Mrs. Theressia Mitchel, Mr. Stanley Rogers, the currently nominated

commissioners of the District, do hereby petition the City Council for the City of North Little Rock, Arkansas ("Council") to appoint the assessors for the District, conditioned upon the filing of the Plan.


The Petitioners petition the Board to name as assessors of the District, Rachel Geist,

The Petitioners have executed this Petition effective December 1, 2016.




