A RESOLUTION AUTHORIZING BONUS PAYMENTS FOR THE SUCCESSFUL COMPLETION OF SIGNIFICANT ELECTRIC DEPARTMENT PROJECTS; AND FOR OTHER PURPOSES.

WHEREAS, on September 23, 2013, the City adopted Resolution No. 8410 authorizing contracts with the United States Army Corps of Engineers, as well as engineers, equipment providers, and construction contractors to extend electric service to the Marion Berry Pump Station at a total cost of \$9,712,928; and

WHEREAS, it is just and proper to award Mr. Eric Heinrich, the Distribution Engineer who supervised the construction project, a salary bonus in the amount of \$2,500.00, for timely completing the two-year project within budget; and

WHEREAS, on September 9, 2013, the City of North Little Rock, Arkansas ("City") adopted Resolution No. 8406 authorizing the 25-year overhaul of Unit 2 of the Murray Hydroelectric Plant at a cost of \$4,591,007.76; and

WHEREAS, it is just and proper to award Mrs. Jessica Stephens, the Hydro Plant Engineer who supervised the overhaul, a salary bonus in the amount of \$1,500.00, for timely completing the two-year project within budget.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That in consideration of timely completing one of the largest electric distribution projects in the history of North Little Rock within budget, Mr. Eric Heinrich is hereby authorized a one-time bonus payment in the amount of \$2,500.00.

SECTION 2: That in consideration of timely completing the largest overhaul of the Murray Hydroelectric Plant in twenty-five (25) years within budget, Mrs. Jessica Stephens is hereby authorized a one-time bonus payment in the amount of \$1,500.00.

SECTION 3: That the funding for this resolution shall be appropriated from the 2015 operational budget of the North Little Rock Electric Department

SECTION 4: That this Resolution shall be in full force and effect from and after its passage and approval.
