**A RESOLUTION SUPPORTING CADDO MOUNTAIN SPRING WATER, LLC, THE DEVELOPMENT OF ITS FACILITIES IN MONTGOMERY COUNTY, ARKANSAS, ITS BUSINESS HEADQUARTERS LOCATED IN NORTH LITTLE ROCK, ARKANSAS AND ENDORSING THE ASSISTANCE OF THE ARKANSAS ECONOMIC DEVELOPMENT COMMISSION INCENTIVES FOR CADDO MOUNTAIN SPRING WATER, LLC**

WHEREAS, Caddo Mountain Spring Water, LLC is making a substantial investment in Montgomery County, Arkansas, to develop a state of the art, high tech, solar powered facility to produce and nationally market local naturally pristine highest quality spring water; and
