**A RESOLUTION APPROPRIATING \$30,000.00 FOR THE COMPLETION OF RENOVATIONS TO AND PURCHASE OF CAGES FOR THE ADOPTION AREA AT THE NORTH LITTLE ROCK ANIMAL SHELTER; AND FOR OTHER PURPOSES.**

WHEREAS, there is a need to renovate the adoption area at the North Little Rock Animal Shelter (“Animal Shelter”), along with purchasing additional cages for housing of animals; and

WHEREAS, the Animal Shelter received \$30,000 in private donations to add air conditioning and part of the needed renovations; and commenced work on the project which has not been fully completed; and

WHEREAS, the City of North Little Rock (“the City”) believes that an additional amount of \$30,000.00 will be sufficient to complete the remaining renovations for the adoption area (\$5,000-\$6,000.00) and purchase additional cages to house animals (approximately \$24,000.00) which will be made pursuant to Ark. Code Ann. § 14-58-303; and

WHEREAS, sufficient funds are available in the General Fund to cover the additional costs of the adoption area project at the Animal Shelter.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the amount Thirty Thousand & 00/100 Dollars (\$30,000.00) is hereby appropriated from the General Fund to be utilized for the completion of renovations to the adoption area at the North Little Rock Animal Shelter facility and to purchase additional cages for housing animals.

SECTION 1: That procurement of items for completion of the adoption area project will be made pursuant to Ark. Code Ann. § 14-58-303.

SECTION 3: That this Resolution shall be in full force and effect from and after its passage and approval.
