A RESOLUTION AMENDING RESOLUTION NO. 9568 (2019 BUDGET) TO AMEND THE FY19 BUDGET FOR FLOOD RELATED EXPENSES OTHER THAN PERSONNEL COSTS; APPROPRIATING FUNDS; AND FOR OTHER PURPOSES.

WHEREAS, through its adoption of Resolution No. 9568 on December 10, 2018 (as amended thereafter by Resolution Nos. 9624, 9659, 9675 and 9679), the North Little Rock City Council approved the budget for the City of North Little Rock, Arkansas (the "City") for the fiscal year 2019; and

WHEREAS, the City of North Little Rock experienced severe flooding beginning on or about May 27, 2019, resulting in significant damage to publicly owned property; and

WHEREAS, the North Little Rock City Council wishes to amend the budget to provide an account from which flood related expenditures, other than personnel costs, should be charged in order to facilitate proper accounting of flood expenses for purposes of reimbursement from the Federal Emergency Management Agency ("FEMA").

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the 2019 Budget for the fiscal year 2019 is hereby amended to add Account No. 01-024-52350 - FEMA Flood Expenses - to the Public Works FY2019 budget for payment of flood related expenses, with the exception of personnel costs (See Exhibit A attached hereto).

SECTION 2: That funds in the amount of \$500,000.00 are hereby appropriated from the General Fund for Account No. 01-024-52350.

SECTION 3: That all resolutions or parts of resolutions in conflict herewith are repealed to the extent of the conflict.

SECTION 4: That this Resolution shall be in full force and effect from and after its passage and approval.
