A RESOLUTION ACCEPTING GRANT FUNDS AWARDED BY THE ARKANSAS HISTORIC PRESERVATION PROGRAM FOR THE REPAIR OF THE PARK HILL FIRE STATION (FIRE STATION NO. 5); APPROPRIATING MATCHING FUNDS; AND FOR OTHER PURPOSES.

WHEREAS, the City of North Little Rock (“the City”) applied for grant funds through the Arkansas Historic Preservation Program (“AHPP”) for repair of the Park Hill Fire Station (Fire Station #5) at 3417 Magnolia Street which application was approved with an award of \$50,000.00 (see letter from The Department of Arkansas Heritage attached hereto as Exhibit A); and

WHEREAS, with acceptance of the grant, the City is required to provide matching funds of \$25,000.00, and the City is prepared to match an additional \$25,000.00 if the cost of repairs exceeds the \$49,070.00 quote, with a total match of \$50,000.00; and

WHEREAS, there is a need for roof repair at the Park Hill Fire Station, and it is in the best interests of the City and its residents to maintain and protect this historical site and proceed with the project; and

WHEREAS, if the additional matched funds are not needed for the roof repair, the funds will be used for leak prevention, mold, and HVAC cleaning.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the City of North Little Rock hereby accepts funds awarded to it through the Arkansas Historic Preservation Program in the amount of \$50,000.00 for roof repair to the Park Hill Fire Station (Fire Station No. 5) located at 3417 Magnolia Street.

SECTION 2: That the City’s local share of \$50,000.00 is hereby appropriated from the Fire Department Act 833 funds.

SECTION 3: That this Resolution shall be in full force and effect from and upon its passage and approval.
