**Final Plat Fees**

Inside the City  
less than 10 acres =\$100  
plus \$1 per lot  
more than 10 acres = \$200  
plus \$2 per lot

Outside the City  
less than 10 acres =\$150  
plus \$1 per lot  
more than 10 acres = \$300  
plus \$2 per lot
