Alderwoman Ross asked if all residents in the area (illustrated on map attached to legislation) had been notified. Mr. Whiting advised Neighborhood Services had sent out notices. He advised he had spoke before the council previously regarding the same issue. Alderwoman White asked about pocket areas not included on the map and if they could be added. She referenced Stanwood Loop as an example. Mr. Whiting said he was relying on the map provided by the North Little Rock Planning Department. Mr. Whiting said residents can ask to be included or excluded from the proposed parking district. Alderman Foutch asked about the condition regarding commercial or large recreational vehicles and if there was something defining length. Alderwoman White asked if a resident placed pavers in the front yard, would be sufficient for a driveway. Mr. Robert Voyles, Planning Director, advised they would and that a resident can pave up to one-half of their front yard. Alderwoman Ross suggested if the legislation passed, that the Legal Department send a letter to all residents (in the parking district) advising them of the law or provide some other form of notification.

AN ORDINANCE GRANTING A SPECIAL USE TO ALLOW A FOOD VEHICLE AS A WALK UP RESTAURANT IN AN R-3 ZONE FOR CERTAIN REAL PROPERTY LOCATED AT 1013 WEST 24<sup>TH</sup> STREET IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES, was read. On the motion of Alderman Taylor and seconded by Alderman Foutch, and by consent of all members present, the rules were suspended and the ordinance was placed on its second reading (7/0). On the motion of Alderman Taylor and seconded by Alderwoman Robinson, and by consent of all members present, the rules were again suspended and the ordinance was placed on its third and final reading (7/0). The ordinance was read a third and final time. Mr. Voyles advised the applicant did not speak English. Mr. Antonio Dominguez was present and spoke through his interpreter. The vehicle will be beside the house and is (like) a mobile home. He would sell tacos, quesadillas and tamales. Alderman Taylor said the applicant was before the council several years ago at which time the council approved him to sell from his truck while renovating his restaurant (see Ordinance No. 8154 Special Use for 915 W. 22<sup>nd</sup> by Rosio Dominguez). The restaurant never opened. The interpreter said he has a food truck he sells from. Alderwoman White referenced event driven food trucks and expressed concerns regarding this as a long term (food truck) location. Acting Mayor Witcher asked about skirting around the trailer. Alderman Taylor said he is not a proponent of mobile food trucks and sponsored the legislation for consideration to provide Mr. Dominquez an opportunity to address the council. Alderwoman Ross said her concern was the location on residential property and that if one is allowed, then more would be requested. Alderman Foutch asked about traffic and parking. Mr. Voyles said the location is off of Pike Avenue on an alley. Parking in the area is low volume. The city owns grass right-of-way in the area. Alderman Baxter asked if there was any opposition to this request when it came before the Planning Commission. Mr. Voyles advised there was not. On the motion of Alderman Taylor and seconded by Alderman Foutch, and the roll having been called, and all members present having voted no, with the exception of Acting Mayor Witcher who voted yes, the motion to adopt failed (1/6). (applicant: Antonio Dominquez) Acting Mayor Witcher suggested Mr. Dominquez visit with Mr. Voyles to see if there was another option.

On Tuesday, July 2, 2013, Park Hill Fire Station #5 will celebrate 75 years. The Park Hill Neighborhood Association is hosting a Birthday party and all residents of Park Hill are invited to attend. The event will be at the Fire Station from 5:00 p.m. until 7:30 p.m. Thursday, June 27, 2013, the Outdoor Storage Task Force will meet at 6:30 p.m. at the North Little Rock Community Center. The public is invited to attend. Alderman Foutch asked for an update regarding the (street) resurfacing program. Mr. Mike Smith, City Engineer, advised the program has progressed better than expected and anticipates the program wrapping up soon. Percy Machin is being milled for overlay now. The project is under budget (approximately \$15,000.00). Acting Mayor Witcher asked them to look at the area 100 feet north of Five Mile Creek on North Hills Boulevard. Alderwoman White asked when the next round of State Road Funds would be available. Mr. Smith had heard the city has been selected (through State Aid For Roads) for the overlay of McCain from North Hills to (Highway) 67. Ms. Pamela Reed lives at 722 Poe Street. When the street was fixed a trench was dug around her house. Now her yard floods. Water has saturated it and now it is deteriorating. The stucco on her house is messed up too. She said there was a temporary fix and she is tired of it. She has neighbor who has a business at his home and won't cut his grass. There's a lot of junk around and he has trees encroaching on her property. Acting Mayor Witcher asked Chief of Staff Danny Bradley to look into her concerns and let Aldermen Taylor and Robinson know of his findings.

There being no further business to come before the Council, and on the motion of Alderwoman Ross and seconded by Alderman Taylor, and by consent of all members present, the meeting was adjourned at 7:44 p.m. (7/0), until the next regularly scheduled meeting to be held on Monday, July 8, 2013, at six thirty o'clock p.m. in the City Council Chambers in City Hall, located at 300 Main Street, North Little Rock, Arkansas.
