The regular meeting of the North Little Rock City Council scheduled for Monday, November 25, 2013, was called to order at 6:30 p.m. by the honorable Mayor JOE A. SMITH. The roll having been called and the following Aldermen answered to their names: DEBI ROSS, MAURICE TAYLOR, LINDA ROBINSON, STEVE BAXTER, BRUCE FOUTCH, CHARLIE HIGHT AND MURRY WITCHER (7/0). Alderwoman BETH WHITE was absent. City Clerk Diane Whitbey and Assistant City Attorney Matt Fleming were also present.

The prayer was given by Mrs. Debbie Stobel followed by the pledge of allegiance to the flag.

On the motion of Alderman Witcher and seconded by Alderman Hight, and by consent of all members present, the minutes of a regular council meeting held on Monday, November 11, 2013, were approved, accepted and filed as prepared by the City Clerk (7/0).

On the motion of Alderwoman Ross and seconded by Alderman Taylor, and by consent of all members present, communication #1 was read by title only, accepted and filed (7/0).

1. Eddie Armstrong, Chair Pulaski County Bridge Public Facility Board letter to Mayors and County Judge re: 2014 Budget for Pulaski County Bridge Facility board request for additional funds for Calendar Year 2014. (*total from each jurisdiction \$41,583.00*)

On the motion of Alderman Baxter and seconded by Alderman Foutch, and by consent of all members present communication #2 was read, accepted and filed (7/0).

2. Ms. Raybonlene Daniels Hill letter to Mayor Smith re: Bus Route for Amboy/Levy Area.

On the motion of Alderman Hight and seconded by Alderman Witcher, and by consent of all members present communication #3 was read by title only, accepted and filed (7/0).

3. Pulaski County Board of Election Commissioners Certification of Election held November 12, 2013, re: Whether or not Alcoholic Beverages may be sold or manufactures (in Park Hill area – Precincts 4M, 4E, 4D, 4Q, and 4P).

Mayor Smith asked Mr. Kc D. Lowery, Chair North Little Rock Outdoor Storage Task Force to come forward. Mr. Lowery provided a presentation (final report) of the task force. Mr. Lowery provided information including facts, real estate values based on outdoor storage, causes of outdoor storage, concerns, recommendations and the definition of outdoor storage. Mayor Smith then presented Certificates of Appreciation to members of the Task Force: Deborah Denton, Dennis Fisk, Kc D.

Lowery, Bob Iriana, Dauphne Trenholm, Joi Whitfield, Jeremy White, Alderman Ross, Alderman Baxter, Daniel McFadden, Firefighter John Pflasterer, Police Officer Karl Sorrels, Caroline Prentice, Russ Elrod, and Jackie Alexander.

Mr. Charlie Baxter, Director Patrick Henry Hays Senior Center to come forward. Mr. Baxter then provided a report regarding the city's new Emergency Operations Center (EOC) at 8th and Main. An emergency plan has been created including all city departments. Mr. Baxter then reviewed the four alert levels, notifications, etc. A press conference was held earlier this date regarding the same.

EXCEPT IN AN EMERGENCY, WHENEVER THE PERMIT APPLICANT PLANS TO BLOCK OR OBSTRUCT INGRESS/EGRESS TO PRIVATE PROPERTY, OR WHENEVER\ THE PERMIT APPLICANT PROPOSES TO PERFORM MAJOR EXCAVATION OR RENOVATION WORK, THE AFFECTED RESIDENTS SHALL BE NOTIFIED AT LEASE 48 HOURS IN ADVANCE BY THE PERMIT APPLICANT. FAILURE TO COMPLY WITH THE NOTIFICATION REQUIREMENT SHALL BE SUBJECT TO SECTION 3.3.2 BELOW. New paragraph IN THE CASE OF SINGLE FAMILY RENTAL HOMES/DUPLEXES OR MULTI-UNIT APARTMENT PROPERTIES, NOTICE SHALL BE GIVEN TO THE LESSEE(S) OF A SINGLE FAMILY DWELLING/DUPLEX OR IN THE CASE OF A MULTI-UNIT APARTMENT BUILDING OR COMPLEX, TO THE MANAGER OF THE BUILDING/COMPLEX (7/0). On the motion of Alderwoman Ross and seconded by Alderwoman Robinson, and the roll having been called, and all members present having voted in the affirmative, the ordinance was adopted as amended (7/0). Emergency clause adopted (7/0).

AN ORDINANCE GRANTING A SPECIAL USE TO ALLOW A DAY CARE CENTER IN A C-2 ZONE FOR CERTAIN REAL PROPERTY LOCATED AT 5532 JFK (JOHN F. KENNEDY)

BOULEVARD; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES, was called and read. Alderman Witcher said there was previous discussion regarding ingress and egress to the

property. The applicant was not present. The Traffic Department recommended not adding another driveway on John F. Kennedy Boulevard. Alderwoman Ross asked if there was room in the back of the property for playground equipment (on the hill). Alderman Taylor said there was a driveway off of JFK. Alderman Baxter said a lot of leaves are on the street and curb and asked what could be

done to educate the public. Mr. Harold Ford, Sanitation Director said door hangers put out by crews. Alderwoman Ross thanked the members of the Outdoor Storage Task Force members for their time and efforts and advised legislation will be forthcoming. Mayor Smith asked council members to provide recommendations regarding the 2014 Budget to Mrs. Scott. Ms. Whitbey reminded everyone that city offices will be closed Thursday and Friday in observance of the Thanksgiving Holidays. Garbage and trash routes will run one-day delayed Thursday and Friday.

There being no further business to come before the Council, and on the motion of Alderwoman Ross and seconded by Alderman Witcher, and by consent of all members present, the meeting was adjourned at 7:40 p.m. (7/0), until the next regularly scheduled meeting to be held on Monday, December 9, 2013, at six o'clock p.m. in the City Council Chambers in City Hall, located at 300 Main Street, North Little Rock, Arkansas.
