Assistant City Clerk Linda Marshall and Assistant City Attorney Matt Fleming were also present.

SPECIAL CALL R-14-15 (RESOLUTION NO. 8479 – MAYOR SMITH) A RESOLUTION AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE AN ADDENDUM TO THE 2013 AGREEMENT WITH ARGENTA DOWNTOWN COUNCIL ("ADC"); AUTHORIZING THE MAYOR AND CITY CLERK TO ENTER INTO A NEW ENHANCED COMMUNITY SERVICES AGREEMENT WITH ADC FOR 2014; APPROPRIATING FUNDS (\$95,000.00 – 2014 Budget); AND FOR OTHER PURPOSES, was read. A motion to adopt was made by Alderman Taylor and seconded by Alderman Foutch. Alderwoman Ross asked why this is being done. Mayor Smith said last year, the council entered into a contract with ADC (for 2013). The process was changed in April (2013) however, services were provided for the entire year. Under the previous conditions, a check could not be issued until the current (2013) contract expired. This will begin a January to January contract. Alderwoman Ross said there are several other non-profit (organizations) that receive funds from the city with contracts scheduled to expire on May 1<sup>st.</sup> and will the council go back on all of them if requested. Mayor Smith said if it is requested and he felt that services were provided within the 12 month period (January – December), he would bring it before the council. Assistant City Attorney Fleming said an addendum would be needed on each agreement. Alderwoman White would like to see all non-profits meet the same requirements and mentioned current work on an application process. Alderman Taylor said this is fixing the previous time frame. Mayor Smith said checks would have been written in the past, however, we have a new administration and new Finance Director so this will clarify this in the future. Alderman Baxter referenced previous comments pertaining to contracts. Alderman Foutch said the Performance Support Document submitted by ADC dated December 2, 2013, does not specifically

state where the \$95,000.00 was spent. According to the report the funds were used to pay salaries for Public Safety Ambassadors', a Green Team which plants flowers and picks up litter. No other area in the city has these. There is no breakdown on where the funds were spent. On the previous motion, and all members present having voted in the affirmative, with the exception of Alderman Foutch who voted no, the resolution was adopted (7/1).

Mayor Smith asked if this process would be done every time a bid is taken. Mr. Fleming recommended doing what state law required. Emergency clause unanimously adopted (8/0).

## **PUBLIC COMMENT**

Mr. Mike Rose lives in the Levy. He asked council members to help in getting a shelter for the elderly people who wait on the bus between MacArthur and Lynn Lane. He has written and called CAT (Central Arkansas Transit Authority), but has not gotten a response. Mr. Thomas Crnko said it has been a year since Nevada Railroad Materials moved on the grounds of Union Pacific Railroad. They continue to break a number of local laws. He asked the council to enforce the law. Twenty-nine residents (29) have complained about this business. Mr. Robert Voyles, Planning Director advised him that the property is zoned for Heavy Industrial. They should have to have a Business License and DEQ (Department of Environmental Quality) permits. Mr. Crnko asked for council support to remove this business from the neighborhood. They do not belong in a city. Mr. Jimmy Ard asked the council to help the House of 3 establish a location in North Little Rock. The applicant did everything legal and was turned down. Mr. Scott Miller thanked the mayor and council for their support to the School District on 23<sup>rd</sup> Street. Mr. Miller spoke regarding a group home that was rejected because it was a business going in a residential neighborhood. Businesses are in neighborhoods all over the city. He urged the council pass legislation that will deal with this issue city wide and not just a particular home or location. There are people renting rooms all over the city. Sometimes five or six different tenants rent rooms in a single-family home. This affects the school district too. The city doesn't have a zoning ordinance applying to single-family homes if a person can purchase a home and then rent rooms to multiple individuals. This is an opportunity to solve to issues (rental property and home care). Mayor Smith asked Mr. Shawn Spencer, Planning Department to get the address of the home across the street from Mr. Miller that he referenced as renting rooms. Mr. Jerry Butler spoke regarding the House of 3 and group homes in residences within the city. He referenced a communication regarding the same. Ms. Jessie Pounds lives in Ridge Road Apartments. The apartments are supposed

to be energy efficient but are not. Elderly residents have received high electric bills. She asked how the apartments could have passed inspection. She asked if the city could work with residents and set up a payment plan on their bills. Alderwoman Ross referenced Mr. Miller's comments regarding rooms being rented out of residential homes. The issue is proving it. If a resident knows of people renting rooms and is willing to come forward and testify that could help.

There being no further business to come before the Council, and on the motion of Alderman Witcher and seconded by Alderman Hight, and by consent of all members present, the meeting was adjourned at 7:25 p.m. (8/0), until the next regularly scheduled meeting to be held on Monday, February 10, 2014, at six-thirty o'clock p.m. in the City Council Chambers in City Hall, located at 300 Main Street, North Little Rock, Arkansas.
