The regular meeting of the North Little Rock City Council scheduled for Monday, May 26, 2014, (Memorial Day Holiday) and held on Tuesday, May 27, 2014, was called to order at 6:04 p.m. by the honorable Mayor JOE A. SMITH.

The roll having been called and the following Aldermen answered to their names: DEBI ROSS, BETH WHITE, MAURICE TAYLOR, LINDA ROBINSON, STEVE BAXTER, BRUCE FOUTCH, CHARLIE HIGHT and MURRY WITCHER (8/0). City Clerk Diane Whitbey and Assistant City Attorney Matt Fleming were also present.

The invocation and pledge of allegiance were lead by Alderman Baxter.

A motion to approve the minutes from the previous meeting was made by Alderman Witcher and seconded by Alderman Hight. Alderman Taylor advised a correction needed to be made to the minutes. The council did not vote to reschedule the meeting scheduled for Monday, May 26, 2014, to Tuesday, May 27, 2014. On the motion of Alderwoman Ross and seconded by Alderman Foutch, and by consent of all members present, the North Little Rock City Council meeting scheduled for Monday, May 26, 2014, at 6:00 p.m. was rescheduled to Tuesday, May 27, 2014, (this date) at 6:00 p.m. On the motion of Alderman Witcher and seconded by Alderman Hight, and by consent of all members present, the minutes of a regular council meeting and Special Call meeting held on Monday, May 12, 2014, were corrected, approved, accepted and filed as prepared by the City Clerk (8/0).

On the blanket motion of Alderwoman Robinson and seconded by Alderwoman Ross, and by voice vote of all members present communications #2, 3, and 4, were accepted and filed without being read (8/0).

On the motion of Alderwoman Ross and seconded by Alderwoman White, and by consent of all members present, communication #1 was read, accepted and filed (8/0).

1. Tom Wadley, Code Enforcement Director letter to Mayor Smith re: Gloryland Family Fellowship Church.

Alderwoman Ross said the reason the city has not demolished the previously condemned building is due to the expense (estimated between \$103,573.00 and \$162,550.00 in 2012). Alderman Taylor said the cost will not decrease and asked why the city wasn't moving forward with the demolition. Mayor Smith said Pastor Hays approached the city about trying to restore his congregation. That didn't happen. Mayor Smith said the problem now is coming up with \$130,000.00. The city will continue to secure the building and cut the grass.

Communication #5 was read. There was no motion to accept or file, therefore, this item will not be part of the permanent record.

5. Glinda Craigmyle, Mayor's Office memorandum re: *Private Club & Retail Beer On Premises – NEW* for The Enjoy Life, Inc., 500 Karrott, by Nikki Killingsworth.

Mayor Smith said North Little Rock Police Chief Mike Davis and Police Officer Andrew Miles are aware of this request.

On the motion of Alderwoman Ross and seconded by Alderman Foutch, and by consent of all members present, communication #6 was read, accepted and filed (8/0).

6. Mayor Smith letter to City Council members re: North Little Rock Health Department and recommendation to remove as city department and reassign employees.

Mayor Smith said North Little Rock was the only remaining city in the state to fund a Health Department. This location provided 3,400 immunizations and 5,000 TB Skin tests last year. WIC (Women and Infant Children) participation was 25,940 and over \$1.7 million in vouchers were issued from this site alone. The State Health Department assured Mayor Smith these services would continue. Negotiations are underway regarding use of the building and utilities. Mosquito Control services would move to a city department. This could save the city between \$200,000.00 and \$250,000.00. The Director, Carey Woods is retiring in June.

Mayor Smith said two (2) new pavilions in Burns Park will be dedicated May 31, 2014, at 10:30 a.m. He invited Zachary Baxla to come forward and explain his Eagle Scout Service Project in the park. Mr. Baxla said one of the pavilions will be dedicated to the Wounded Warriors of Arkansas. The second pavilion will be dedicated to the Native Americans of Arkansas and the Historical Trail of Tears. Mr. Baxla said businesses that helped by donating items including over \$13,000.00 in materials were Baldwin & Shell Construction Company, Home Depot, Kaufman Lumber Company, Razorback Concrete Company, Reed's Metals of Benton, Signs & Lines Graphic Art, Brenda's Portable Toilets, Brundage-Bone Concrete Pumping, Jugg & Hall Mobile Storage, and Hum's Hardware & Rental. Donated labor brought the value of the donations up to \$40,000.00. Mr. Baxla said he chose this project because he had family members who serve and have served in the military. He also met a woman at Pinnacle Mountain named Shining Star who shared many stories about Native Americans. Mayor Smith invited Alderwoman White to join him at the podium where he presented a Proclamation

to Mr. Baxla making May 26, 2014, his day in the City of North Little Rock and commended him for his efforts. Alderman Hight said some of the local cyclists have been using the pavilions as a resting area.

Mayor Smith announced a Special Call scheduled for Tuesday, May 27, 2014, at 6:01 p.m.

A motion to adopt was made by Alderman Taylor and seconded by Alderman Foutch. North Little Rock Electric Department Acting General Manager C. Jason Carter advised there was a (mechanical) failure at the Plum Point Power Plant. In the past, the city had no decisions if there was an outage. If there was an outage, the city purchased (replacement) power at \$53.96 per megawatt hour. The city now has the option of purchasing power through the market place. Plum Point will be down for at least 45 days. The city has to decide whether or not to purchase power daily or enter into a contract that would provide more predictability. Mr. Carter then reviewed the Modified EEI Master Agreement, cover sheet and remaining contracts included in the remaining Special Call items. The Base Term Agreement will be with Nextera Energy. The Energy Authority, Inc. would be inserted in the blanks in R-14-84. There are similarities and differences between the two companies (Nextera and Energy Authority) which are based on the type of organization. O-15-54 is an amendment to the existing NRG Agreement. O-14-55 agrees to a transaction. Mr. Carter referenced the Risk Management Committee which is chaired by North Little Rock Finance Director Karen Scott. The purpose of the committee is to evaluate risk and price and enter into the most favorable agreements for the city. The price would not exceed \$45.00 per megawatt hour and not to exceed 45 days. Alderman Foutch asked how this will affect electric customers. Mr. Carter said a similar event occurred last year. Replacement power was at a fixed price of \$53.96 per megawatt hour. The monetary effect should be half as much as last year. Mayor Smith said the ECR (Energy Cost Recovery) is averaged over six (6) months. Alderman Hight noticed his electric bill went up about \$6.00 to \$8.00 a month. Mr. Carter said that was due to the pervious outage. On the previous motion, and by consent of all members present, the resolution was unanimously adopted (8/0).

Mrs. Rhodes said if the city is purchasing the food for an event then a variety of healthy food options should need to be included. Mayor Smith advised this is a large project including (Pulaski) County, the City of Maumelle and the City of North Little Rock. North Little Rock's portion is 5/13 of 20 percent. On the previous motion, and by consent of all members present, the resolution was unanimously adopted (8/0). (\$40,000.00)

O-14-50 (ORDINANCE NO. 8647 – MAYOR SMITH)

AN ORDINANCE ADOPTING AN UPDATED DRAINAGE BASIN MAP; RESTATING THAT STORM WATER IMPACT FEES SHALL BE EXPENDED WITHIN THE DRAINAGE BASIN FROM WHICH COLLECTED; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES, was read. On the motion of Alderman Baxter and seconded by Alderman Foutch, and by consent of all

members present, the rules were suspended and the ordinance was placed on its second reading (8/0). On the motion of Alderman Hight and seconded by Alderman Baxter, and by consent of all members present, the rules were again suspended and the ordinance was placed on its third and final reading (8/0). The ordinance was read a third and final time. Alderman Witcher said the drainage funds never accumulate much money and inquired if there was a requirement for the city to do this. City Engineer Mike Smith said repairs need to be made to a pipe along Colonel Maynard Road. After an extensive study, it was determined to be in the Faulkner Lake Drainage Basin which has \$95,000.00. Alderman Taylor said the map indicates the Dark Hollow Basin goes across the railroad tracks and near Scott. He then asked why that basin runs that far down the east side of the city. Mr. Smith said that is the direction the water drains. Alderwoman Ross said there is nothing in this legislation regarding requiring the council's approval of use of funds. On the motion of Alderman Hight and seconded by Alderman Baxter, and the roll having been called, and all members present having voted in the affirmative, with the exception of Alderman Taylor, who voted no, the ordinance was adopted (7/1). On the emergency clause, all members voted in the affirmative, with the exception of Alderman Taylor, who voted no, emergency clause adopted (7/1).

O-14-51 (ORDINANCE NO. 8648 – MAYOR SMITH)

AN ORDINANCE VACATING AND ABANDONING PLATTED AND UNDEVELOPED PORTIONS OF 51ST STREET AND MARGARET STREET (A/K/A 52ND STREET) IN THE CITY OF NORTH LITTLE ROCK; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES, was read. On the motion of Alderman Baxter and seconded by Alderman Foutch, and by consent of all members present, all readings were suspended (8/0). On the motion of Alderman Hight and seconded by Alderman Foutch, and the roll having been called, and all members present having voted in the affirmative, the ordinance was unanimously adopted (8/0). Emergency clause unanimously adopted (8/0). (requested by Habitat for Humanity)

O-14-52

AN ORDINANCE GRANTING A SPECIAL USE TO ALLOW CAR SALES IN A C-3 ZONE FOR CERTAIN REAL PROPERTY LOCATED AT 4620 EAST BROADWAY IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES, was read. There was no motion, therefore the item was held on the agenda. (applicant: Steffanie Mahaney)

Mr. Ard referenced The House of Three and a possible lawsuit and fees to cover the same. Alderman Taylor asked if the city has a Strategic Plan, Mission Statement of List of Goals. Alderman Hight said members of the Old Mill Master Gardeners wanted him to thank the Parks Department for their work at the Old Mill recently. Alderwoman White said Arkansas Trails Day will be Saturday, May 31,

2014, at Burns Park. There will be a presentation at 1:30 p.m. along with a lot of events throughout the day. Alderwoman Ross said students with the East Initiative need votes for their project. They are competing for 100 volunteer hours and \$5,000.00. To vote on Facebook, go to North Little Rock Community Farm or regionsbanknews.com/vote and scroll down to North Little Rock Community Garden to vote. Alderman Baxter participated in the Special Olympics Torch Run last week with members of the North Little Rock Police Department. Mayor Smith said Traffic Services set up a traffic count in Burns Park recently on a weekend. There were four (4) different locations. One heads towards the Golf Course and Soccer Fields. Another location headed towards the ball parks and tennis courts. Both locations had 5,500 vehicles each day at each location. The count did not include Military Drive. Mayor Smith said there were several events including a Soccer Tournament and Dragon Boat Races.

There being no further business to come before the Council, and on the motion of Alderwoman Ross and seconded by Alderman Foutch, and by consent of all members present, the meeting was adjourned at 7:15 p.m. (8/0), until the next regularly scheduled meeting which will be held on Monday, June 9, 2014, at six o'clock p.m. in the City Council Chambers in City Hall, located at 300 Main Street, North Little Rock, Arkansas.
