The regular meeting of the North Little Rock City Council scheduled for Monday, March 27, 2017, was called to order at 6:00 p.m. by the Honorable Mayor Joe A. Smith.

The roll having been called and the following Aldermen answered to their names: DEBI ROSS, BETH WHITE, MAURICE TAYLOR, LINDA ROBINSON, STEVE BAXTER, RON HARRIS, and CHARLIE HIGHT (7/0). Alderman MURRY WITCHER was absent. City Clerk Diane Whitbey and City Attorney C. Jason Carter were also present.

The prayer and pledge of allegiance were led by Alderman Baxter.

On the motion of Alderman Hight and seconded by Alderman Harris and by consent of all members present, the minutes from the North Little Rock City Council meeting held on Monday, March 13, 2017, were approved, accepted and filed as prepared by the City Clerk (7/0).

On the motion of Alderwoman Ross and seconded by Alderman Baxter, and by consent of all members present, communication #1, was read by title only, accepted and filed (7/0).

Alderman Hight reminded the public that the council meeting could be watched through a Live Feed on Facebook.

People continue to work out of and store items in a "temporary" building. Code Enforcement or Planning needs to follow-up on it. PUBLIC COMMENT

Mr. James Ard referred to packets and pictures he provided council members and an item that came before the council 10 years ago. The location is on West 57th.

Mayor Smith then provided copies of the 2017 State of the City to council members. For several years, the population of the city has declined. It appears that since 2010, the population of the city is going up (estimated at 6.6% increase). The (current) financial state of the city is the result of calculated and cautious financial management. Our city is over 100 years old. This presents inescapable infrastructure issues. Current city officials need to look ahead to the future. North Little Rock Police Chief Mike Davis and Fire Chief Jim Murphy have done great jobs providing public safety to our residents. Mayor Smith said he learned today that the cities (Fire) ISO Rating had gone from a 2 to a 1. North Little Rock is one of six cities in the state and 243 across the country with an ISO 1 rating. Mayor Smith referenced Chief Murphy's recent death and the service provided by the North Little Rock Fire Department. He commended Fire Chief Gerald Tucker for their efforts. Mayor Smith referenced Economic Development and the quality of life in the city, including high paying jobs. However, expenses continue to rise. Increases include costs of equipment and employee health insurance. Overall expenses are up 36%. Revenue has stayed the same. Mayor Smith then highlighted some of the departments, including Human Resources, Volunteer Services, Vehicle Maintenance, Engineering/Traffic, Parks and Recreation, Planning, Safety Department and IT. These departments have exceled either through saving money/generating revenue, and streamlining various processes. Expenses in the Sanitation Department continue to climb. North Little Rock is one of three cities (Jonesboro, El Dorado) in the state that do not charge residents for sanitation pickup. Sherwood is the only other city to provide leave pickup. North Little Rock's sales tax (1 cent) is the second lowest in the state. Mayor Smith also referenced several charts included in the report. Some options to consider would be a sales tax increase or Sanitation fee. Mayor Smith asked the council to review the information and advised the next council meeting will convened at 5:30 p.m. to allow time to ask questions and for discussion.

There being no further business to come before the Council, and on the motion of Alderman Taylor and seconded by Alderwoman Ross, and by consent of all members present, the meeting was adjourned at 7:13 p.m. (7/0), until the next regularly scheduled meeting which will be held on Monday, April 10, 2017, at five-thirty o'clock p.m. in the City Council Chambers in City Hall, located at 300 Main Street, North Little Rock, Arkansas.
