Council Member MAURICE TAYLOR was absent. City Clerk Diane Whitbey, Deputy City Clerk Talor Shinn and City Attorney Amy Fields were also present.

The prayer and pledge of allegiance were led by Council Member Baxter.

COMMUNICATION FACILITIES IN THE RIGHT-OF-WAY; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES, was read. On the motion of Council Member Baxter and seconded by Council Member Robinson, and by consent of all members present, the readings were suspended (7/0). Mr. C. Jason Carter, Attorney for North Little Rock Electric Department distributed documents related to this legislation to council members which included an Executive Summary and Summary of Amendments. Mr. Carter said people use the internet for business, social, entertainment, etc. To engage in these activities, the public needs to be able to move lots of data quickly and reliably. Sometimes this is done across a wired connection, but more-and-more access is wirelessly across cellular networks. Significant improvements in cellular infrastructure to meet the data demands that are forecasted for the next several years is needed. The industry's solution has been called small cells. Traditional cell towers located throughout the city carry voice and data for lots of users across a large footprint with a limited data transfer rate. Small cells have shorter range and support fewer users, but at a significantly higher speed. Small cells are proposed to work in conjunction with traditional cell towers to provide users both data reliability and speed. From the wireless service providers' perspective, installation in the right-of-way presents the fastest and most cost-effective method to deploy small cell devices. It allows providers to avoid many property acquisitions and maintenance costs. By using existing poles in the right-of-way for attachment, wireless service providers can make construction faster, more predictable and less costly. From the city's perspective, reliable high-speed data communication is important, but so are other public concerns like safety, efficiency, fairness, appearance and cost recovery. The current legal landscape places few restrictions on the city in regulating small cells, but that could change. The proposed regulation is intended to fairly balance competing interests of the city while providing a reasonable environment for the deployment of small cell devices. Key components include safety, efficiency, fairness, appearance and cost recovery. Mr. Carter expressed his appreciation to the City of Conway, AT&T and AT&T President Ronnie Dedmond. Council Members asked several questions which were answered by Mr. Carter. Mr. Carter then reviewed the Summary of Amendments: Page 6, Section 1.20: correction to the definition of Overhead; Page 7, Section 1.29: Definition of "Tag" modified to approximate industry standards; Page 7, Section 1.30: Traffic Pole is defined under 1.24. This extra definition should be deleted; Page 9, Section 2.2.4: Descriptive words have been deleted as superfluous; Page 17, Section 4.5: Amended to specifically allow tags to be constructed of plastic; Page 25, Section 7.7.3: Allows for minimal changes to equipment after installation without re-permitting; Page 26, Section 8.2: Allows for device to be used when inspection cannot be performed in five days, subject to later inspection; Page 26, Section 8:3: Assures prompt inspection; Page 26, Article 9: Clarifies that space will not be reallocated unless/until permit is abandoned; Page 28, Section 11.3: Clarifies that only one spare custom pole of each type needs to be provided. Throughout: Post-Installation Inspection changed to a capitalized term. Amend in APPENDIX B-1. Mr. Carter referenced the design included in "B-1". Council Member Ross asked if this applied to wooden poles only. Mr. Carter confirmed "B-1" did. Council Member Harris asked about the fee structure which Mr. Carter discussed. Mayor Smith said he has consulted with people around the country. Mr. Carter said the Electric Department has a digitized map which will include the location of these devices. On the motion of Council Member Ross and

seconded by Council Member Robinson, and by consent of all members present, the ordinance was amended as follows:: see Summary of Amendments from Mr. Carter above (7/0). A motion to adopt as amended was made by Council Member Witcher and seconded by Council Member Hight. Mayor Smith then convened a scheduled public hearing. Mr. James Ard asked how electricity will be supplied to the devices. Mr. J. T. Zakrewski said it is good that the city is working with AT&T on this project. Mr. Zakrewski said when a cell tower goes in fiber has to be ran. He asked if new fiber would have to be installed in the neighborhoods. Mr. Carter said data will be handled across fiber to the internet. Mr. Carter anticipated the first installations could be in use by October. There being no one else wishing to be heard, the public hearing was adjourned. On the previous motion, and the roll having been called, and all members present having voted in the affirmative, the ordinance was adopted (7/0). Emergency clause adopted (7/0).

Mr. Ard said Mr. Penney isn't returning telephone calls. The area (Mr. Penney is developing) needs to be developed. However, the owner is clearing land without permits or netting. Mr. Chris Corbitt spoke regarding the Building Code. He said he would read from a section that is being enforced against him. Under permit required, the word shall has legal connotations, may or must could have been used. It shall be unlawful for any person to install, repair, replace, or perform any work in the city without a permit from the Community Planning Department. Except for two items: Painting interior or exterior and floor covering. Mr. Corbitt said he is a licensed Professional Engineer in about seven states, a licensed Attorney, and a Master Plumber. Mr. Corbitt said certain activities council members have engaged in is a violation of the law. He referenced replacing a light bulb, door knob, toilet flapper or toilet. In his legal opinion, the city needs to look at the code. Mr. Corbitt invited council members to meet with him. Council Member Hight said a tree fell and was blocking Randolph last week and was blocking the road. He called Street Department Director Patrick Lane to report it. When he came through five minutes later, Director Lane was sawing and trimming the tree so vehicles could get through. Council Member Hight commended him for his work. Council Member Ross said it has been her goal to get generators in all of the city's fire stations. Last week Station 3 was without power all night. The employees had to get into their turnouts in the dark and the doors were locked. None of the three stations in Ward One have a generator. She asked the city to move forward with getting generators in all stations. Mayor Smith said there is a possibility that Station 3 will be relocated.

There being no further business to come before the Council, and on the motion of Council Member Hight and seconded by Council Member Ross, and by consent of all members present, the meeting was adjourned at 7:10 p.m. (7/0), until the next regularly scheduled meeting to be held on Monday, August 13, 2018, at six o'clock p.m. in the City Council Chambers in City Hall, located at 300 Main Street, North Little Rock, Arkansas.
