The regular meeting of the North Little Rock City Council scheduled for Monday, August 27, 2018, was called to order at 6:00 p.m. by the Honorable Mayor Joe A. Smith.

The roll having been called and the following Council Members answered to their names: DEBI ROSS, BETH WHITE, LINDA ROBINSON, STEVE BAXTER, RON HARRIS, CHARLIE HIGHT and MURRY WITCHER (7/0). Council Member MAURICE TAYLOR was not present during roll call. City Clerk Diane Whitbey, Deputy City Clerk Talor Shinn and City Attorney Amy Fields were also present.

The prayer and pledge of allegiance were led by Council Member Hight.

On the motion of Council Member Witcher and seconded by Council Member Ross and by consent of all members present, the minutes from the North Little Rock City Council meeting and a Special Call meeting held on Monday, August 13, 2018, were approved, accepted and filed as prepared by the City Clerk (7/0).

Council Member Taylor entered the council chambers at 6:01 p.m.

On the motion of Council Member Baxter and seconded by Council Member Ross, and by consent of all members present, communications #1, 2, 3, and 4, were not read, but were accepted and filed (8/0).

On the motion of Council Member Ross and seconded by Council Member Robinson, and by consent of all members present, communication #5 was read, accepted and filed (8/0).

 Melissa Ervin, Community Development Director, Notice of Public Hearings and Funding Availability for Fiscal Year 2019: Community Development Block Grant (CDBG) and Home Investment Partnership (HOME) funds. Public hearings scheduled for August 28, 29 and 30, 2018.

Mayor Smith invited Mr. Gary Sipes, Executive Director, Arkansas Chiefs of Police Association and North Little Rock Police Chief Mike Davis to come forward. Mayor Smith said Mr. Sipes is a retired North Little Rock Police Officer and a former Police Chief. Mr. Sipes said the Arkansas Chiefs Association selected Mayor Smith as Arkansas Mayor of the Year for 2018. In 2010, the association looked at ways to make law enforcement agencies in the state more professional. Training, policies and best practices were needed. The majority of state agencies have 10 or less staff. Arkansas joined 27 other states by creating a Law Enforcement Accreditation Program. An agency has to meet 188 standards before being considered for accreditation. Mr. Sipes presented a Certificate of Accreditation to North Little Rock Police Chief Mike Davis, making the North Little Rock Police Department the 12th in the state to receive the designation. Chief Davis thanked the City Council and Mayor for their continued support.

No one signed in to speak on legislation.

Mayor Smith thanked Ms. Boykin and Ms. Williford (who were not present) for their continued service to the city as commission members.

A RESOLUTION AUTHORIZING THE MAYOR AND CITY CLERK TO ENTER INTO A REAL ESTATE DEVELOPMENT AND OPTION TO PURCHASE AGREEMENT, FOR PROPERTY LOCATED ON MAIN AND 6TH STREETS, WITH J. CHANDLER & COMPANY, INC; AND FOR OTHER PURPOSES, was read. A motion to adopt was made by Council Member Baxter and seconded by Council Member Ross. Mayor Smith advised the city previously gave Mr. Chandler an option (to purchase) on a property on Main Street where the city is now building a three-story building. Mr. Chandler agreed to void the option in exchange for this property (next to the Downtown Argenta Plaza site). Council Member Ross asked about the length of time, which is up to one-year. Mayor Smith said Mr. Chandler is working with potential restaurant tenants and needs the time. When the city begins dirt work on the Plaza, it will also do the dirt work on this property and bill Mr. Chandler for his portion. If Mr. Chandler has not purchased it by the time the Plaza is finished the city could use if for parking or green space. On the previous motion, and by consent of all members present, the resolution was unanimously adopted (8/0).

R-18-167 (RESOLUTION NO. 9502 – MAYOR SMITH)

A RESOLUTION APPROPRIATING ADDITIONAL FUNDS FOR THE CONSTRUCTION OF THE ARGENTA PLAZA; AND FOR OTHER PUROSES, was read. A motion to adopt was made by Council Member Baxter and seconded by Council Member Harris. Mayor Smith said construction plans were finished and bid. The bid came in \$800,000.00 over the original amount. After meeting with the architect and contractors, some things were changed which reduced costs by \$200,000.00. However, removing additional items would affect the quality of the project. Mayor Smith said a consultant working on the Justice Building project advised the costs of construction have been rising about one percent per month over the past 18 months. Another reason for the increase in costs, was an increase in the size of the plaza. Mayor Smith said the addition of the First Orion Building (which will bring 200-300 new jobs to North Little Rock) resulted in an increase in the overall plaza site by about 25%. Current property sales and future sales will cover expenses. Council Member Ross said none of the recently passed one-cent sales tax funds will be used for this project. Council Hight asked if any funds would be left in the Special Projects Infrastructure Fund. Mayor Smith reminded council

members there is not a contingency fund on this project and said that everything has been bid and prices are set. On the previous motion, and by consent of all members present, the resolution was unanimously adopted (8/0). (\$665,500.00)

PUBLIC COMMENT

Mr. Bobby Taylor continues to have issues with his neighbor and trash. He went to court this month and his neighbor didn't show up. The Judge issued a warrant for failure to appear. His neighbor has had three garage sales without a permit in the last five months (the city allows one per quarter — otherwise it is considered a business). The trash piles are causing rats which are entering his (Mr. Taylor's) home. The court won't do anything. Mayor Smith said he has no control over the judicial system. Mr. Taylor suggested the city bring out a truck and pick up the trash. Mayor Smith said the city has to follow the law. Mr. Taylor said someone from Waste Management called him regarding his issue with misused recycling bins. Mayor Smith said he will meet with Regional Solid Waste tomorrow regarding negotiations to extend the contract the city has in place. Mayor Smith said it looks like there will be at least a one-dollar increase (from \$2.99 to \$3.99 per month). Mr. James Ard asked the Police Chief to come forward and thanked him and the department for how they handled a situation

where two youth had ran away from DHS (Department of Human Services). Council Member Robinson said there have been recycling issues with residents mixing/putting things into the recycling bin that shouldn't be there. Mayor Smith said the contamination rate issue is part of the on-going negotiations for recycling. There are two neighborhoods where the contamination level is above 90%, meaning 9 out of 10 carts are contaminated. Mayor Smith said the city is prepared to start picking up containers from violators. Waste Management plans to give two warnings before removing a container. The resident will still have to pay the fee even if their container is removed for repeated contamination. China is no longer accepting recycled materials from the United States so there is no longer a market for some of the materials. Council Member White has had complaints about liquid leaking from garbage trucks. Mr. Harold Ford, Sanitation Director told her the trucks are not water tight. Some of the issues are due to garbage bins either being left open or not having a lid. When it rains, water accumulates inside the container and is dumped into the truck with the trash. This is an issue with recycling containers as well. Council Member Baxter said city code requires that garbage/trash containers have a lid and regulates maximum size. Council Member Ross referenced the inclusion of plastic bags (Kroger/Wal-Mart bags) in the current contract for recycling. Council Member Ross said the public needs to be educated. Council Member Ross asked for an update on the Police and Fire projects which are being funded by the sales tax. Mayor Smith said an architect was chosen for two fire stations. One will be in Levy and the other will be in Burns Park. These were the selections of the Fire Chief and his assistants. In Levy, there were two properties (approximately 6 blocks from the existing station) under consideration that had to be appraised. Station 7 on McCain will be remodeled at a cost of about ¼ million dollars. The Maumelle Station will be fixed/remodeled. Station 8 (old Conway Highway) would relocate to Burns Park, (which would provide quick access to the Interstate). Regarding the Police building, an architect from Kansas City was selected. A contract has not been signed yet. This was delayed due to property exchanges that had to take place (between North Little Rock School District, Arkansas National Guard and City of North Little Rock). Mayor Smith said he was concerned about rising construction costs. Council Member Witcher referenced the current City & Town Magazine which is published by the Arkansas Municipal League (AML). Mayor Smith is currently serving as President of the state-wide organization. Mayor Smith advised that AML Head Legal Counsel was named Executive Director during the annual Executive Committee Meeting last week. Council Member Taylor asked what the plan is for the Fire Station located on the eastern side of the city. Mayor Smith said the city just purchased the property. The Firefighters who are stationed there love the station location, separate bedrooms and kitchen area. That station was not on the list to be renovated or rebuilt. Council Member Taylor said his constituents were told the station would be temporary and that a permanent building and possible police substation would be built in the future. Mayor Smith suggested they talk with the firefighters stationed there. Council Member Robinson agreed with Council Member Taylor's comments. Ms. Whitbey reminded residents of the upcoming (Labor Day) holiday. Garbage, trash and recycling routes will be delayed one-day all week.

There being no further business to come before the Council, and on the motion of Council Member Witcher and seconded by Council Member Ross, and by consent of all members present, the meeting
