present, the resolution was adopted (5/0).

Council Member Ross announced a (second) Saint Patrick's Day Color Run will take place (Saturday, March 16, 2019) in Levy and Park Hill. Registration is from 7:30 until 9:15 a.m. at Levy Baptist Church. There will be a mini-mile down the Levy Trail and a Family Fun Run for more experienced participants. The event will include a Health Fair. Council Member Taylor asked for an update on negotiations with the (North Little Rock) Fire Union. Chief of Staff Danny Bradley said the Mayor presented a letter last week. The Union responded with a letter late Friday. Mayor Smith is out of town and has been unable to review it. Chief Bradley said the city has had two (recent) meetings with the Union and an agreement has not been reached at this time. Mr. Lynn Dereuisseaux, President of the International Association of Firefighters (North Little Rock) said (the Union) responded to the Mayor's letter. As a result of the (Mayor's) letter they are at a stalemate at this time. There were issues from November that were being discussed. Mr. Dereuisseaux said the Mayor asked that they review the remainder of the contract which resulted in approximately 15 additional issues. Council Member Ross said the council just passed legislation regarding Police contracts for a period of two (2) years and asked if the Firefighters were considering a two (2) year or one (1) year contract. Mr. Dereuisseaux said the Mayor offered two (2) or three (3) years. They (the Union) will be looking at the Police Department contract to see what kind of raise was included. They (the Union) will want the same amount if not more. Negotiations are for other items within the contract at this time. Employees have been getting overpaid and underpaid for the last few months that needs to be resolved. It isn't clear if the issue is with payroll or the software. Council Member Ross asked Emergency Management Director Leonard Montgomery questions regarding the (Emergency) Warning System issues (delay) from last Saturday. Mr. Montgomery said the way the system operated previously is how it operates now. When a warning is received, an operator has to manually activate the system. The city has new software that will automate the process which will be activated tomorrow (March 12, 2019). Once the system is automated, when a storm warning goes out affecting North Little Rock, the system will activate automatically, without operator intervention. The dispatcher will still maintain manual control for activation if necessary. Council Member Ross said there were also delays in Sherwood and Little Rock.

There being no further business to come before the Council, and on the motion of Council Member Taylor and seconded by Council Member Ross, and by consent of all members present, the meeting

was adjourned at 6:14 p.m. (5/0), until the next regularly scheduled meeting to be held on Monday, March 25, 2019, at six o'clock p.m. in the City Council Chambers in City Hall, located at 300 Main Street, North Little Rock, Arkansas.
