### SPECIAL CALL (RESOLUTION NO. 9897 – MAYOR SMITH)

A RESOLUTION AUTHORIZING APPLICATION BY THE NORTH LITTLE ROCK POLICE DEPARTMENT FOR FUNDS UNDER THE 2020 EDWARD BYRNE JUSTICE ASSISTANCE GRANT (JAG) PROGRAM; AND FOR OTHER PURPOSES, was read. A motion to adopt was made by Council Member Ginn, and seconded by Council Member Ross. Council Member Ross asked what

a non-lethal weapon was and why it was needed. Interim Police Chief Tracy Roulston said it is a weapon not intended to cause serious injury or death and is an alternative to the use of deadly force. The department would like to have more available to officers for use in the field (patrol). This is a newer weapon that has been shown to be effective. The second part of the request is for first responder first aid kits that would be issued to every officer. If the officer is injured, he or she would have a personal first aid kit that could be utilized by someone providing assistance. Mayor Smith said the city has 184 officers and approximately 50-60 non-lethal weapons at this time. Council Member Ross asked about the cost of sponge bullets. Chief Roulston said the weapon shoots a 40 millimeter compact sponge inside of a shell casing. The casing is discharged at a high speed and can temporarily incapacitate an individual for a period of time. The cost is approximately \$24.00 per round. Each officer will have a total of four (4) rounds. On the previous motion, and by consent of all members present, the resolution was unanimously adopted (8/0).

Note: those wishing to speak during public comment were allowed to call into the meeting and placed in a call-waiting room. They will be called upon as or if needed as legislation is called.

He spoke with Mr. Lucas Hargraves (applicant), and was able to obtain what he needed. Council Member Ross asked why electric fences were not allowed. Mayor Smith convened a public hearing. There being no one present wishing to be heard, the public hearing was adjourned. On the motion of Council Member Taylor and seconded by Council Member Robinson, and by consent of all members present, the resolution was unanimously adopted (8/0). (applicant: Amarok, LLC)

If the fences are equal in height, a burglar or criminal could stand on the perimeter fence and step over the (electric) fence and step into the yard. The extra three (3) strands of wire which are visible above the eight (8) foot perimeter fence, create a total of ten (10) feet. The wire is also an alarm so if cut, an alarm will go off. On the previous motion, and the roll having been called, and all members present having voted in the affirmative, the ordinance was unanimously adopted (8/0). Emergency clause unanimously adopted (8/0). (applicant: Amarok, LLC)
