The regular meeting of the North Little Rock City Council scheduled for Monday, May 24, 2021, was called to order at 6:00 p.m. by the Honorable Mayor Terry C. Hartwick.

The roll having been called and the following Council Members answered to their names: DEBI ROSS, NATHAN HAMILTON, MAURICE TAYLOR, LINDA ROBINSON, STEVE BAXTER, RON HARRIS, JANE GINN, and CHARLIE HIGHT (8/0). City Clerk/Treasurer Diane Whitbey, and City Attorney Amy Fields were also present.

Note: the majority of the Council Members participated in the meeting electronically. Mayor Hartwick, City Clerk Whitbey, City Attorney Fields, Council Members Ross, Hamilton, and Ginn were present in the council chambers.

The prayer was led by Council Member Baxter.

On the motion of Council Member Hight and seconded by Council Member Baxter, and by consent of all members present, the minutes from the North Little Rock City Council meeting scheduled for Monday, May 10, 2021, were approved, accepted and filed as prepared by the Chief Deputy City Clerk, Katelyn Thomas (8/0).

### **PRESENTATIONS**

Chief of Staff Tracy Roulston provided an update regarding the recent Rose City Focus project April 26 thru May 27, 2021. Multiple departments participated including police, fire, sanitation, code enforcement, street and electric. Notifications were sent to residents of the area. Fire Department crews visited 101 residences. They installed 101 smoke detectors and replaced batteries. Door hangers were left at locations where no one answered the door which resulted in additional smoke detector installations. A number of vacant structures were also located. Code Enforcement had 26 assigned calls and 213 initiated calls. There were 313 follow-ups resulted in 8 citations. 209 violation notices were also issued. 19 vehicles were tagged and 8 locations were advised of high-grass. An additional 106 lots were posted. 12 structures and 5 rental properties were inspected. The street department cleaned ditches and drains and patched pot holes. Sanitation ran extra vehicles. Traffic services checked road markings and cross walks. They also checked signs and replaced any that were damaged. The Electric Department replaced lights that were out. Chief Roulston said he would like to see one event per quarter possibly in each ward. Mayor Hartwick said he received a call from Mr. Bobby Taylor commending the city for these efforts.

### RESOLUTIONS

R-21-68 (RESOLUTION NO. 10046 – MAYOR HARTWICK)

A RESOLUTION AUTHORIZING THE MAYOR AND CITY CLERK TO ENTER INTO PURCHASE AND SALE AGREEMENT AND LEASE AGREEMENT WITH GREYHOUND LINES, INC.; AMENDING THE FY2021 BUDGET (RESOLUTION NO. 9963); AND FOR OTHER PURPOSES, was read. A motion to adopt was made by Council Member Ross and seconded by Council Member Taylor. Mayor Hartwick asked Mr. John Owens, President/CEO North Little Rock Chamber of Commerce and Mr. Robert Birch, Economic Development Director to come forward. Mayor Hartwick said an offer and acceptance was made which included a one-year lease agreement. Mr. Owens said the location of the bus station has created a disruption in the area. The (Arkansas) Department of Correction drops off released inmates who have the opportunity to take the bus and leave the area. However, many times they do not. The business also attracts a lot of people who do not live in the community who are either waiting to pick up someone or take a bus. People often have to wait up to 18 hours for a bus with no shelter, money or options. Mr. Birch advised the company had planned on relocating by March (2021), however, the planned location had changes. The company no longer needs a large facility. The plan is for a smaller footprint, preferably attached to a convenience store with highway access nearby. Eighty-five percent of the riders in this area are from Little Rock. Council Member Hight referenced possible (illegal) activity and asked if a police officer was assigned

to the location. Mr. Birch said it is not local people causing the issues. Mayor Hartwick said no officer is assigned however, the department receives a lot of calls (regarding disturbances, etc.). Council Member Hamilton said this will not alleviate issues with homeless people, etc. Greyhound has been looking for a location where riders would not be stranded and have access to services. The city is not kicking Greyhound out. The company wanted to relocate to a location that will better serve their current business needs. Council Member Ross asked how long the location had been in North Little Rock. Mr. Birch advised since 1987. On the previous motion, and by consent of all members present, the resolution was unanimously adopted (8/0). (\$650,000.00 or \$665,000.00)

Mayor Hartwick convened a public hearing regarding R-21-69 – 520 West 14<sup>th</sup> Street, R-21-70 – 2320 West 16<sup>th</sup> Street, R-21-71 – 119 Beech Street, and R-21-72 – 123 Beech Street. A PowerPoint Presentation was shown during the public hearing which included photos of all of the properties illustrating their current condition. Interim Code Enforcement Director Felicia McHenry advised Code Enforcement has not been contacted by any of the owners. A lot of older people have sold properties that investors bought without seeing them (or the condition they are in). There being no one present wishing to be heard, the public hearing was adjourned.

Mr. Barber said the funds are budgeted. This request is for a sole source exemption. The vendor has done the majority of the work in the city. They also have the expertise to do the job right. This is part of a larger, multi-phase future improvement to the current fiber infrastructure. Council Member Hamilton said some of the fiber is on poles. The request to go underground is understandable. On the previous motion, and the roll having been called, and all members present having voted in the affirmative, the ordinance was unanimously adopted (8/0). Emergency clause unanimously adopted (8/0). (\$87,365.45)

O-21-43 (ORDINANCE NO. 9355 – MAYOR HARTWICK (for consideration only)

AN ORDINANCE GRANTING A SPECIAL USE TO ALLOW AN EVENT CENTER IN A R2

ZONE FOR CERTAIN REAL PROPERTY LOCATED AT 503 MORRIS IN THE PLANNING

JURISDICTION OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS; DECLARING AN

EMERGENCY; AND FOR OTHER PURPOSES, was read. On the motion of Council Member

and all members present having voted in the affirmative, the ordinance was unanimously adopted (8/0).

Center)

O-21-44 (ORDINANCE NO. 9356 – COUNCIL MEMBERS ROSS AND HAMILTON) AN ORDINANCE GRANDING A CONDITIONAL USE TO ALLOW A COFFEE SHOP WITH A DRIVE THROUGH IN A CPH ZONE FOR CERTAIN REAL PROPERTY LOCATED AT 3515 JOHN F. KENNEDY BOULEVARD IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES, was read. On the motion of Council Member Ross and seconded by Council Member Hamilton, and by consent of all members present, the readings were suspended (8/0). A motion to adopt was made by Council Member Ross and seconded by Council Member Hamilton. Council Member Ross said there is limited space between the buildings. However, there is adequate space between the buildings for drive through traffic. Mr. Spencer said the city does not regulate the operation of the business. A survey illustrates there is adequate room. Council Member Ross said there have been concerns about traffic backing up on JFK (John F. Kennedy Boulevard) and referenced other locations like Chick-Fil-A and Snoop-Dog where there are similar issues. However, this is not within the city's authority. Council Member Hamilton said he is glad to see this could be a popular location. Council Member Ross added the owner, Mark Whitehead has a drive through location in the Hobby Lobby parking lot, which will also remain open. Ms. Whitbey reminded Mr. Whitehead he will need to get a Business License for the new location. On the previous motion, and the roll having been called, and all members present having voted in the affirmative, the ordinance was unanimously adopted (8/0). Emergency clause unanimously adopted (8/0). (applicant: Mark Whitehead/Dark Side Coffee)

## PUBLIC COMMENT

Mayor Hartwick will meet with several employees tomorrow regarding (fully) opening city offices (June 1, 2021). He said there have been multiple opportunities for anyone who wanted to get a COVID-19 vaccine to do so. He will visit with the council members later in the week. Council Member Robinson asked if the Event Center outside city limits will be required to obtain a city

business license. Ms. Whitbey advised they will not. If they do come into the city to conduct business, a city license would be required. Council Member Baxter asked if the Mosquito Truck is running. Mayor Hartwick said it starts tonight. Council Member Harris said a (3-day) Balloon Fest event will be held in the Northshore Park (at the driving range) this weekend. Council Member Robinson said city offices will be closed, Monday, May 31, 2021. Trash and garbage routes will run one-day delayed all week.

There being no further business to come before the Council, and on the motion of Council Member Ross and seconded by Council Member Taylor, and by consent of all members present, the meeting was adjourned at 6:39 p.m. (8/0), until the next regularly scheduled meeting to be held on Monday, June 14, 2021, at six o'clock p.m. in the City Council Chambers in City Hall, located at 300 Main Street, North Little Rock, Arkansas.
