Grant funds designated specifically for bridges will be available later in the year. Council Member Ross said this would be a 20% match for the city. She referenced ARPA Funds and asked if some of those funds could be used. On the previous motion, and all members present having voted in the affirmative, the resolution was unanimously adopted (8/0).

It has no floor and was not rented but used for storage. The building on Parkway has not been rented either. Mr. Cagle stores his personal items in it. He lives cattycorner to the building. He planned to put in a

weight room, library, and video room. He had problems with the property before when the right side of the roof was collapsing. Code Enforcement told him to fix it, which he did. The left side has collapsed. He talked to someone about fixing the other side. He said he was told by Code Enforcement he might be wasting his money if the property is condemned. Mr. Ward Reese, Assistant Code Enforcement Director said he spoke to Mr. Cagle the previous week. Mr. Cagle told him he had not been in the building at 2300 Parkway in 10 years. Mr. Reese said the city had to obtain a search warrant to be able to enter the building which was filled with items. Code staff had to take photos from the front door as entry was not possible. Mr. Reese said 5910 MacArthur was in the same condition. The outside is a little better. Code Enforcement had to obtain a search warrant for this property as well. It was also filled with items. The property used to be used as a Flea Market. Mr. Reese said the floors have deteriorated and referenced the photos provided to City Council. City Attorney Fields advised Mr. Cagle of the process if the property is condemned. He can contact the City Attorney's Office to enter into a Rehabilitation Agreement which would give him an additional 120 days to rehabilitate the properties. He would be required to provide a (cash) bond in the amount of the cost to demolish the structure. Failure to rehabilitate the property would result in the bond being forfeited to raze the structures. Mayor Hartwick said he drove by the properties. He advised Mr. Cagle he had returned his call, however he was unable to leave a message. There being no one else present wishing to be heard, the public hearing was adjourned.

On the motion of Council Member Baxter and seconded by Council Member Taylor, and by consent of all members present, the readings were suspended (8/0). A motion to adopt was made by Council Member Hamilton and seconded by Council Member Ginn. Mayor Hartwick convened a public hearing. Council Member Hight asked if this included the sewer ponds in Burns Park. Mr. Michael Clayton, North Little Rock Waste Water Director advised these bonds are designed for mostly interceptor renewal projects. There are large diameter pipes throughout the system that need to be replaced. Improvements also include consolidation of the Maumelle Waste Water Treatment Facility and the White Oak Facility. Council Member Ross asked how many Waste Water Bonds there were now. Mr. Clayton said the percentage of principal and interest is about \$4,107,859.00. The 2022 Bond Ordinance would entail another \$2.6 million plus interest. The total would be about \$6,784,261.00. Compared to annual revenue the percent would be roughly 29%. The Little Rock Waste Water Authority bonds are at about 39%. There being no one present wishing to be heard, the public hearing was adjourned. On the previous motion, and the roll having been called, and all members present, having voted in the affirmative, the ordinance was unanimously adopted (8/0). Emergency clause unanimously adopted (8/0).

AN ORDINANCE REPEALING ORDINANCE NO. 9004; REVOKING A SPECIAL USE FOR A MOBILE HOME IN AN R2 ZONE FOR CERTAIN REAL PROPERTY LOCATED AT 7001 FAULKNER LAKE ROAD IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS;

DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES, was called. City Attorney Fields said a public hearing needs to be held on this item. The property owner's attorney contacted Ms. Fields and advised they would not be able to attend this meeting. The ordinance was read. On the motion of Council Member Ross and seconded by Council Member Baxter, the rules were suspended and the ordinance was placed on its second reading (7/1). Mayor Hartwick convened a public hearing. There being no one present wishing to be heard, the public hearing was recessed until Monday, April 11, 2022. Council Member Taylor asked the reason for the appeal. Ms. Fields said the property owner had been granted a Special Use to allow a mobile home for a period of three (3) years. The ordinance was then held by the sponsor, Mayor Hartwick.

AN ORDINANCE WAIVING CERTAIN PROVISIONS OF SECTION 5.11 OF THE ZONING ORDINANCE (ORDINANCE NO. 9263) FOR PROPERTY LOCATED AT 13101 HIGHWAY 70 TO ALLOW THE WAIVER OF FENCE REQUIREMENTS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES, was read. On the motion of Council Member Taylor and seconded by Council Member Ross, and by consent of all members present, the readings were suspended (8/0). A motion to adopt was made by Council Member Taylor and seconded by Council Member Robinson. Mayor Hartwick convened a public hearing. There being no one present wishing to be heard, the public hearing was adjourned. On the previous motion, and the roll having been called, and all members present having voted in the affirmative, the ordinance was unanimously adopted (8/0). Emergency clause unanimously adopted (8/0). (applicant: Thomas R. Pownall of Thomas Engineering Company)

PUBLIC COMMENT

Council Member Hight said a property on Candlewick Drive was condemned thirteen weeks ago. Neighbors had been complaining about the location for years. The council entered into a Rehabilitation Plan giving the owner 6 months to bring the property up to code. Council Member Hight said nothing has been done since then and residents are complaining. Council Member Hight asked what can be done to ensure those who have entered into an agreement with the city actually follow through with it. City Attorney Fields said the owner will be given notice at the end of the six (6) month period and advised they have failed to comply with the terms of the agreement and notice the city will proceed with demolition of the structure. This will result in the city keeping the escrow (bond) that was paid to the city.

There being no further business to come before the Council, and on the motion of Council Member Baxter and seconded by Council Member Ross, and by consent of all members present, the meeting was adjourned at 6:57 p.m. (8/0), until the next regularly scheduled meeting to be held on Monday, April 11, 2022, at six o'clock p.m. in the City Council Chambers in City Hall, located at 300 Main Street, North Little Rock, Arkansas.
