June 13, 2022 Six o'clock P.M. North Little Rock City Hall Council Chambers 300 Main Street North Little Rock, Arkansas

The regular meeting of the North Little Rock City Council scheduled for Monday, June 13, 2022, was called to order at 5:58 p.m. by the Honorable Mayor Terry C. Hartwick.

Due to the rise in COVID-19 cases and Arkansas Governor Asa Hutchinson reinstating a state-wide public health emergency, council members had the option of attending the council meeting in person or participate virtually. The Council Chambers were open to the public.

The roll having been called and the following Council Members answered to their names: DEBI ROSS, NATHAN HAMILTON, LINDA ROBINSON, STEVE BAXTER, RON HARRIS, JANE GINN and CHARLIE HIGHT (7/0). Council Member MAURICE TAYLOR was absent. City Clerk/Treasurer Diane Whitbey and City Attorney Amy Fields were also present.

The prayer and pledge of allegiance were led by Council Member Harris.

On the motion of Council Member Hight and seconded by Council Member Ross, and by consent of all members present, the minutes from the North Little Rock City Council meeting scheduled for Monday, May 23, 2022, were approved, accepted and filed as prepared by the City Clerk, Diane Whitbey (7/0).

On the blanket motion of Council Member Baxter and seconded by Council Member Hamilton, and by consent of all members present, communications #1, 2, 3, 4, 5 and 6, were accepted and filed (7/0).

### **PRESENTATIONS**

Mrs. Strange, Chief Financial Officer introduced Ms. Rachel Ormsby – BKD CPAs and Advisors, Dallas, Texas. Ms. Ormsby is the Audit Director for the city's external audit. The city received a clean, unmodified opinion for the 2021 Financials. This is the highest level of assurance that can be made. When a city spends more than \$750,000.00 in Federal Expenditures a separate, single audit is required. The City of North Little Rock spent approximately \$5.2 million in Federal Expenditures. The bulk was ARPA (American Rescue Plan Act) funds. The city received a clean opinion on internal control for financial reporting and compliance with federal guidelines. The City of North Little Rock has received the highest level of recognition for financial reporting from GFOA (Government Finance Officers Association) for two consecutive years. The future of accounting includes a GASB (Government Accounting Standards Board) accounting standard on leases. This will include buildings, vehicles, or any type of lease asset to be included in financial statements. This will fall under a "right-to-use" asset and corresponding financial liability. In 2023, this will include IT subscription based arrangements across the city. Ms. Ormsby advised governments are susceptible to cyber security risks and this needs to be kept at the forefront. Council Member Harris commended Mrs. Strange for her efforts and team.

Mayor Hartwick said last week was Waste and Recycle Workers Week. He presented a Proclamation and commended North Little Rock Sanitation Director Condo Breedlove and his team for their work in North Little Rock.

Council Member Hamilton asked if the material terms were included in the legislation. Ms. Fields said there were. Council Member Baxter asked if this was for the turf for the playing surface as required under the new Major League Baseball (MLB) contract. Chief of Staff Mike Davis said the city had made the initial deposit and the sod has been ordered. Other items include what is under the field like irrigation, etc. Council Member Ross said the resolution indicates "improvements" not sod, etc. Mr. Davis said irrigation within the field is included in this legislation. City Attorney Fields said the contract would include design and planning for the field, root zone selection and oversight, sod selection and oversight, and irrigation design and installation. Mayor Hartwick referenced R-22-111 which was previously adopted. Mr. Davis said that \$800,000.00 is for damage related to previous flooding (and damage to wells). On the motion of Council Member Ross and by Council Member Ginn, and by consent of all members present, the resolution was amended as follows:: Section 1, insert after 4Most Sports, WAIVE FORMAL BIDDING IN CONNECTION WITH MLB MANDATED IMPROVEMENTS TO DICKEY STEPHENS PARK BY 4MOST SPORTS FOR DESIGN AND INSTALLATION OF IRRIGATION AND SOD TO THE DICKEY STEPHENS PARK FIELD. Ms. Godwin said the main need of many residents in North Little Rock is a new roof on their homes, which have deteriorated due to rot, etc. The OMP received 39 applications, which were solicited through neighborhood associations. They were able to complete 9 homes in North Little Rock. Construction costs have gone up which includes the cost of shingles and lumber.

### **PUBLIC COMMENT**

Mayor Hartwick announced the upcoming Boots and Badges Blood Drive, June 17, 2022, at the Justice Center in North Little Rock. Mayor Hartwick asked Council Member Robinson to provide an update regarding voting precincts in Ward 2. Council Member Robinson attended five (5) meetings with the Pulaski County Election Commission, in addition to numerous messages with and for constituents regarding recent changes to voting precincts in Ward 2. She commended the residents of Ward 2 who were also involved. Voters who used to vote at City Hall will now vote at the Argenta Branch Library, one block up the street. Voters who were at the Glenview Community Center will vote at the Rose City Recreation Center. In addition, the Glenview Community Center will now be an additional Early Voting site. This gives the City of North Little Rock two early voting sites: one at Laman Library and one at the Glenview Community Center. Council Member Robinson said she has received requests to meet with individuals and their attorneys to discuss city business. City Attorney Fields said she would recommend city officials, department heads, etc. only meeting with someone (and their attorney) if the City Attorney or a staff member is also present.

There being no further business to come before the Council, and on the motion of Council Member Ross and seconded by Council Member Baxter, and by consent of all members present, the meeting was adjourned at 6:43 p.m. (7/0), until the next regularly scheduled meeting to be held on Monday, June 27, 2022, at six o'clock p.m. in the City Council Chambers in City Hall, located at 300 Main Street, North Little Rock, Arkansas.
