He will be working with the applicant on permits, etc. This is a very flat area and drainage should not be an issue. The applicant will still be subject to conditions under Section 3 of this ordinance. ### **NEW BUSINESS**

Mayor Hartwick convened a public hearing on the following items:

R-22-126 - 5818 Crystal Hill Road, R-22-127 - 4316 Burkes Avenue, and R-22-128 - 1101 Cache River Road. Ms. Melissa Johnson and her contractor Mr. Spivey were present. Mr. Spivey said he just got the paperwork signed three (3) weeks ago to begin construction. The house is posted no construction at this time. He has provided an estimate to be presented to the insurance company. Mrs. Felicia McHenry, Code Enforcement Director said there was a fire at the location in November, 2021. Their department has been trying to contact Ms. Johnson since that time. An initial inspection was done in November. A follow-up inspection was a few weeks ago. The property is in the same condition as illustrated in photos provided to council members. Mrs. McHenry said Code Enforcement has received numerous complaints on this location. Some were prior to the fire. Citations have been issued in the past. Mrs. McHenry said she was advised by Ms. Johnson previously that she had a Restoration Company to work on the property. However, a signed contract was never provided. A few weeks ago Ms. Johnson advised the city she had another Restoration Company to work on the property. Council Member Hight said several of the neighbors from Cache River were also present. Council Member Ginn asked if Code Enforcement had inspected the swimming pool. Ms. Johnson said she is trying to get it repaired and it has a cover on it. Council Member Ginn said the pool issue goes back three (3) years. Council Member Hight referenced the fire (November, 2021) and advised

there was an explosion in the house a few years ago. There has also been a death in the swimming pool. The house has been a nuisance for many years. Damaged inoperable vehicles have also been parked on the street. Ms. Somer Clark-Day is the Overbrook Property Manager. She said over the past decade there have been dozens of complaints about 1101 Cache River Road. The swimming pool has been untouched for several years and is a cesspool for mosquitos and disease. It would benefit the community if Ms. Williams were able to repair the home. Unfortunately, there has been very little communication. No permits have been pulled. Ms. Clark-Day referenced six (6) neighborhood residents who were present with concerns. The lawn hasn't been mowed, shutters are hanging loose, and the fence is in disrepair. There being no one else wishing to be heard, Mayor Hartwick adjourned the public hearing. Council Member Ross said if the property is condemned, the property owner can still enter into a Rehabilitation Agreement with the City Attorney. Deputy City Attorney Lee said the property owner has the opportunity to enter into a Rehabilitation Agreement which would require funds to be put in an escrow account in an amount sufficient to demolish the house if the repairs are not made within an allowed period of time (included in the agreement). Council Member Hamilton said this gives the homeowner another opportunity, but also requires funds to proceed. Council Member Ross asked how long the owner has to contact and enter into an agreement with the City Attorney. Ms. Lee said it is 30 days. Council Member asked if the other residents (on Cache River) and Ms. Johnson understand where this stands at this time. All nodded that they did.

They will also notify customers through email. Planning will also notify the State Licensing Board of the change. Council Member Ross asked if the notification

### **PUBLIC COMMENT**

Mr. Jesse "Rocky" McDaniel spoke about Rock Region Metro bus service to residents to the east end of North Little Rock. The Board is proposing reducing buses in the area and replacing them with a "Connect Service" where a rider would call and a van would pick them up and take them to a bus stop where buses are running. The rider would then catch the bus to ride to their destination. They would have to do they would have to do the same thing to return home. The reason mentioned was low ridership in the area. Mr. McDaniel said this is a bad idea. A lot of people don't have a phone or internet connection to be able to use the "Connect" method. Rock Region Metro has indicated they have issues accessing funds because they are unable to get local "matching" funds from local cities. Mr. McDaniel asked that the city look into this and consider additional funding. He said due to higher fuel prices more people are using public transit. The goal is to help people get back to work, but they need help to get there. Mr. McDaniel said Rock Region Metro is basing their information on a study

from 2019. Mr. Brian Lambert is a member of the Arkansas Bow Hunters Association. He said due to the number of vehicle accidents caused by deer, there are numerous cities around the state that allow members to hunt Whitetail Deer. He would asked if the city could meet with their Vice President and Game Warden Ralph Meeker to discuss the possibility of Urban Deer Management. Mayor Hartwick said the city used to allow North Little Rock Police Officers to hunt in Burns Park. North Little Rock Police Chief Patrick Thessing said they do at White Oak only. Mayor Hartwick asked that they write him a letter with their request and he will refer it to the City Attorney. Mr. Lambert said there have been 18 deer/vehicle accidents in the city. Nationwide (2012/2013) insurance agencies paid over \$75 million in damaged vehicle claims. Council Member Taylor asked if language regarding the process (following a condemnation) to enter into a Rehabilitation Agreement be included with legislation. Council Member Baxter said Interstate access from Curtis Sykes is being closed. Mayor Hartwick said City Offices will be closed Monday, July 4, 2022, in observance of the July 4th Holiday. Garbage, trash and recycling routes will run one-day delayed all week (i.e. Monday's pickup with be Tuesday and so on). Council Member Ross reminded everyone Fireworks are prohibited (within the North Little Rock) city limits. Mayor Hartwick announced the 38th Annual Pops on the Fireworks will be at 9:30 p.m. Monday, July 4, 2022. There are opportunities to watch the Fireworks at the Arkansas Inland Maritime Museum.

There being no further business to come before the Council, and on the motion of Council Member Ross and seconded by Council Member Hamilton, and by consent of all members present, the meeting was adjourned at 6:54 p.m. (8/0), until the next regularly scheduled meeting to be held on Monday, July 11, 2022, at six o'clock p.m. in the City Council Chambers in City Hall, located at 300 Main Street, North Little Rock, Arkansas.
