

AN ORDINANCE ENTITLED AN ORDINANCE AMENDING ORDINANCE NO. 1645 AS PASSED BY THE CITY COUNCIL OF NORTH LITTLE ROCK DECEMBER 8, 1947 AND ORDINANCE NO. 1681 AS PASSED BY SAID CITY COUNCIL FEB. 9, 1948, TO BETTER REGULATE THE GENERAL LICENSES IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS; AND REPEALLING ALL ORDINANCES OR PARTS OF ORDINANCES CONFLICTING HEREWITH."

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1. That Ordinance No. 1645 as passed by the City Council of North Little Rock, Arkansas, December 8, 1947 and Ordinance No. 1681 as passed by said City Council February 9, 1948 be, and is, hereby amended to read as set out hereinafter.

SECTION 2. That it shall be unlawful for any person, firm or corporation, or individual in the City of North Little Rock, Arkansas to engage in or carry on any of the following businesses, trades, occupations, vocations, callings or professions without first having obtained and paid the license therefor from the City Collector the amount of which licenses are hereby fixed by this ordinance.

SECTION 3. That the word "STOCK" used in this Ordinance shall include not only goods, wares and merchandise, but all other articles and things carried for sale distribution by any persons, firms, corporations or individuals, at one location.

SECTION 4. For the sake of convenience and to avoid repetition under several items, the following schedule of licenses to be charged is hereby created and defined and called "SCHEDULE A" AND HEREIN REFERRED TO AS SCHEDULE A." The said license fees as fixed by this Ordinance under SCHEDULE A shall be respectively levied as follows, to wit:

Each person or firm acting as a broker in the City of North Little Rock, Arkansas shall obtain from the City Collector a license for which he shall pay as follows:

SECTION. 112 Any person, firm or corporation within the City of North Little Rock engaging in the business of selling any and all kinds of goods, wares, and merchandise, whether raw materials or finished products, or both, from a regularly established place of business maintained within the City of North Little Rock; unless otherwise provided in Section 1 above, shall pay on the 1st day of January of each year, an annual privilege tax for the privilege of doing business within the City of North Little Rock in an amount equal to four-tenths (4/10) of one per cent (1%) of the gross value of the average stock inventory for the preceding year. The minimum privilege tax for such businesses shall be Fifteen Dollars (\$15.00) The value of the goods shall be the price paid therefor by the tax payer. Said inventory shall be furnished to the City Collector in a sworn statement setting forth the total amount.

B. The City Inspector of Weights and Measures or his duly authorized deputy shall have the right to check and audit the stocks, books, and records of any person, firm or corporation subject to the license fee as provided in this section. Should any person, firm or corporation refuse to allow the City Inspector of Weights and Measures or his Agent, to examine the stocks, books, and records, the Collector shall refuse to issue a license to such person, firm or corporation, provided, however, if a license has been issued, the City shall immediately revoke such license.

C. The City Collector shall collect penalties for the failure to pay the privilege tax as provided in this section as follows:

1. Five per cent (5%) of the amount due when the payment is made within thirty (30) days past the due date of the license fee.
2. Ten per cent (10%) of the amount due when the payment is made within Sixty (60) days past the due date of the license fee.

Any person, firm or corporation within the City of North Little Rock engaging in the business of selling and all kinds of goods, wares, and merchandise, whether materials or finished products, or both, from a regularly established place of business maintained within the City of North Little Rock, unless otherwise provided in Section 110, shall pay on the 1st day of January of each year, an annual privilege tax for the privilege of doing business within the City of North Little Rock in an amount equal to four-tenths (40) of one per cent (1%) of the gross value of the average stock inventory for the preceding year. The minimum privilege for such businesses shall be Fifteen Dollars (\$15.00). The value of the goods shall be the price paid therefor by the payer. Said inventory shall be furnished to the City Collector in a sworn statement setting forth the total amount.

B. The City Inspector of Weights and Measures or his duly authorized deputy shall have the right to check and audit the books, books, and records of any person, firm or corporation subject to the license fee as provided in this section. Should any person, firm or corporation refuse to allow the City Inspector of Weights and Measures or his Agent, to examine the books, books, and records, the Collector shall refuse to issue a license to such person, firm or corporation, provided, however, if a license has been issued, the City shall immediately revoke the license.

upon the receipt of the amount of the privilege tax provided herein to issue a license under this ordinance for every person, firm, or corporation liable to pay such tax, and to state in each license issued, the amount thereof, the period of the time covered thereby, the name of the person, firm, or corporation to whom issued, the business, occupation, or profession to be carried on, and the location or place where such business, occupation or profession is to be carried on and in no case shall any mistake in stating or computing the amount of a license due prevent or prejudice the collection by the City of what shall actually be due under this ordinance.

SECTION 5. Any person, firm, or corporation engaging in two or more businesses, occupations, or professions, and for which a license is required of each, shall pay for and take out a license for each business, profession, or occupation.

SECTION 6. It shall be unlawful for any person, firm, or corporation, whether as principal or agent, to commence, engage, or carry on any of the aforesaid businesses, occupations, corporations within the City of North Little Rock without having first paid the privilege tax and procured a license therefor.

SECTION 7. The period covered by any license paid shall be for one (1) year, if issued before April 1st., after April 1st, three-fourths (3/4) of one year, after July 1st, one-half (1/2) of one year and after October 1st, one-fourth (1/4) of one year will be collected.

SECTION 8. Each license shall be posted in a conspicuous place where such business, occupation or profession is carried on, and the holder of such license shall show such license to any agent of the City of North Little Rock, upon request.

SECTION 9. Any license issued hereunder is not subject to transfer from person to person, firm, or corporation.

SECTION 10. Any person, firm, or corporation doing business in the City of North Little Rock without the payment of the privilege tax hereinabove provided, and without having been issued a license to transact its business, shall be guilty of a misdemeanor, and upon conviction in the North Little Rock Municipal Court shall be subject to a fine of not less than \$5.00, nor more than \$500.00, and each day of violation shall constitute a separate offense.

SECTION 11. It shall be unlawful for any person to knowingly and wilfully make any false written affidavit as to the amount of stock on hand, or volume of gross receipts, revenues, or business, or amount of capital invested in business, or number of employees or vehicles used or to file such affidavit with the City Collector or any license collector or inspector, or any deputy license inspector or collector, for the purpose of defrauding the City of North Little Rock by procuring a license for a less sum than is lawfully due by the affiant, or his principal.

SECTION 12. Should any section, or part of section or provision of this ordinance be for any reason held void or invalid, it shall not affect the validity of any other section or provision hereof which is of itself not void or invalid.

SECTION 13. All ordinances and parts of ordinances in conflict herewith are hereby repealed.

SECTION 14. At the present time various privilege taxes are unjust and inequitable and thereby having the effect of requiring various persons to pay an unjust proportion of taxes, and to bear an unjust share of taxation and because of said inequities it deprives the City of North Little Rock of revenue needed to maintain the police, fire and health protection, therefore, an emergency is hereby declared to exist, and this ordinance is found to be necessary for the preservation of the public peace, health and safety of the citizens of the City of North Little Rock, and the same shall be in full force and effect from and after its passage and approval.
