Things to think about before adopting

Take your time making a decision. With all the adorable “fur babies in need of homes, you might be tempted to make a snap decision. However, it will be better for your future furry BFF if you put some thought into it. For example, do you live in an apartment, or a house with a yard? Does your family travel a lot? Who will be there to let your dog out when you’re not home? Do other family members want a new pet as much as you do?

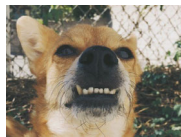
Adopting means getting a pet from a shelter. Even though there are many wonderful dogs and cats waiting in shelters for someone to adopt them, breeders and some stores continue to produce and sell animals to make money. For every pet bought from a store or breeder, another has to be put to sleep (euthanized).

Make sure your family’s wallet can handle it. Some pets require a lot of care that can quickly add up to big bucks. When you are a responsible pet owner, you need to spend money on regular (and sometimes emergency) vet visits. You will also need bedding, a collar and harness, high-quality food and treats, toys, grooming and more!

It is important to get your pet spayed or neutered.

Every year millions of animals in the U.S. are left at animal shelters, and half of them are euthanized because there were not enough good homes for them. The only way to help stop this is to make sure that no more unwanted puppies or kittens are born.

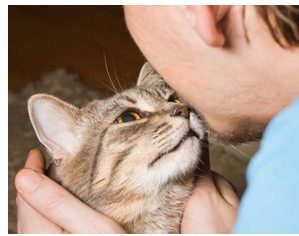
Microchipping. Accidents happen and you never know if or when your pet will get loose or run away. If you couldn’t find your way back home, you’d be able to call for help, that is not the case for our pets. For dogs, get a collar with proper tags that have your dog’s name and at least two phone numbers for your or your family. Microchipping is a simple procedure a veterinarian can do. This is a great way to make sure your pet gets back home again. If you move, make sure you update your pet’s tags and give the microchip company your new information.



Pets need their teeth cleaned, too.

Dental health is as important as human oral health. If you don’t brush your fur babies teeth, ask your vet about annual cleaning.

Don’t forget a mani/pedi. Dogs’ nails should be trimmed regularly so they don’t break, get snagged on something (which can hurt), or get so long they interfere



with normal walking—if a dogs’ nails grow too long, it can affect their gait and even nervous system.

Fur. Fur babies need to be groomed. Regular brushing helps prevent matting and increases circulation to the skin. Brushing also provides spend-

ing quality time together and can be a nice bonding experience.

Keep an eye on what your pet eats. Some foods that are fine for people can be poisonous to pets. High on the list is chocolate, but that’s not all. Some other foods that could be harmful are onions, grapes, raisins and macadamia nuts. Be careful not to overfeed your pet either as this can result in obesity.

Toys and exercise. Before adopting a pet, be sure to hide dangerous items such as chemicals, electrical wiring and sharp objects. Also put away things that might be mistaken as a “pet toy”, like papers, pillows and such. Consider pet-friendly toys for your pet. And keep in mind your dog or cat might need a little walk or game of “mouse” to keep them active.

Training. Every day is a training opportunity. The key to a happy pet is to set clear rules and boundaries. It is important to reward your pet for good behavior.

Preventing fleas, ticks and worms. This is important from late spring into fall when these little critters are the most common. And don’t forget heartworms. Where there are mosquitos, you will usually find heartworms—heartworm disease can kill dogs. Thankfully, prevention is as simple as a monthly medication.

Do not leave your dog chained up outdoors. It’s hard to imagine a dog outside, especially in bad weather, but it happens. It can be cruel and dangerous to your pet.

NEVER leave your dog in the car. Temperatures inside cars can skyrocket in a matter of minutes—even if it’s not particularly hot outside. If you see a pet locked in a car, call 911.

Last but not least, give your pet plenty of love and affection.

Your pet’s life is much, much shorter than the average human’s life. It goes by quickly, so be sure your pet’s BFF and show him or her lots of love every single day!

A few New Years Eve Safety Tips

New Years Eve is a great chance to celebrate the year gone by and the coming of a new one. However, these celebrations also come with great dangers and responsibility. Here are a few tips to keep in mind as you make your plans!

New Years Eve Driving

After midnight, New Years celebrations end and millions take to roads and public transportation to make their way home. The combination of sheer number of travelers plus the inevitability of irresponsibly impaired drivers makes for a dangerous evening on the roads and one of the deadliest days for drunk driving in the nation. Over 50% of accidents on New Years Day involve high blood alcohol concentration.

If you are celebrating away from home, or traveling at all, here are some ideas to keep you safe.

- Plan travel options in advance by designating a driver, hotel stay, shuttle/limo or other transportation.
- Check for local ride programs.
- If you must leave your vehicle behind, park in a populated, well-lit area. Roll up windows, lock all doors and ensure all valuables are left at home or secured and out of sight.
- Bring only what you need with you when heading out—ID, money and one credit card. Leave other cards and valuables at home.

New Years Day is also hazardous for pedestrians. Not only are drivers potentially impaired, but those on foot can also ignore traffic lights and crosswalks. If you are walking, make sure you stay on pedestrian paths and observe traffic laws; only cross at crosswalks and try to remain in well-lit areas. If you are driving, take extra care to consider those on foot.

Party Hosts

Hosting a New Years Eve party can be a great way to spend time with friends and families (and also to control the environment of the party), but hosting comes with great responsibilities. In addition to providing a great party atmosphere, consider these tips to keep your guests safe.

- Make sure smoke alarms are working and have fresh batteries.
- Research numbers for local hospitals and authorities and have them ready in the case of an accident.
- Contact a local cab company to provide rides for your guests, or have a trusted designated driver ready to take guests home if necessary.
- Offer non-alcoholic drink options and have plenty of water available.
- Use differently colored cups for alcoholic and non-alcoholic beverages. Dump unattended cups so kids and pets do not consume them.
- Stop serving alcohol several hours before the party ends (and stick to it!).
- Provide food and snacks so guests aren't drinking on an empty stomach. Avoid salty snacks, which can actually encourage people to drink more.
- Do not provide alcohol to minors. Keep an eye on all drinks and supplies.
- Provide guests a place to stay overnight should they need to. Even if accommodations are less than ideal (like a blanket on the floor), they will be safe!



Fireworks are illegal in the city limits of North Little Rock

This is a reminder fireworks of any kind are illegal within our city limits. It is unlawful for any person to possess, store, offer for sale, sell at retail, set off, ignite or otherwise explode any fireworks by whatever name called within the city of North Little Rock.

Anyone found in possession of fireworks could be fined and fireworks will be confiscated and destroyed.

Residents may call the North Little Rock Police Department non-emergency number at 501-758-1234 to report the use of fireworks in their neighborhood.

Pets and Fireworks

- If fireworks are being used near your home, put your pet in a safe, interior room to avoid exposure to the sound.
- Make sure your pet has an identification tag, in case it runs out an open door.

Mayor Terry C. Hartwick holds a monthly department head meeting. Department heads provide a report of activities, projects and accomplishments.

Below are highlights from November 2021 (You will see that some departments had to change operations due to the Coronavirus/COVID-19.

Hays Center—fully open to members. 6,027 members visited in October, average 200 members per day. 59 new members. Arkansas League of Artists artwork on display. Volunteers contributed 524 hours.

Street—work in the street department is never ending...crews patch potholes, pick up litter, clean out storm drains (remove accumulated debris including leaves and grass clippings).

Sanitation—crews continue to pickup garbage and yard waste during the pandemic. Garbage / Yard Waste crews collected 2,195.03 tons (4,390.60 lbs) of household garbage, rubbish and junk. Yard waste crews collected 85 loads (2,357.80 cubic yards) of green waste. Leaf crews picked up (1,140.62 cubic yards) of loose leaves. 252 tires picked up. 23 Sanitation Code inspections and 23 re-inspections. Issued 8 notices for non-compliance. Leaf vacuums season began November 1.

Traffic—AR One Call requests—40 (*reminder—calling One Call will save time and money — time by locating underground utility lines—money by not having to pay to repair damaged underground utility lines!*), Signs/posts repaired or replaced—230, City vehicles marked with decals—3. Set up Speed Trailer at 3101 North Hills. Set up Stealth Box on Idlewild, Kierre, North Hills and Pollock

Fire—Total incidents— 824, Fires-56, False alarms-36, Rescue/Emergency Medical-491, Hazmat-16, False Alarm—65. Training hours: 2,551. Building surveys: 114.

Emergency/911—Incoming calls-11,701, Non-911-5,855, Wired 911-669, Abandoned 911-24, Wireless 911— 4,883, Abandoned Wireless-270. Total dispatch entries: 7,516.

Planning—Inspectors traveled 2,235 miles within the city performing the following inspections: 116 HVAC, 174 Plumbing, 228 Electrical, 151 Building. Issued the following permits: 6 sign, 1 demolition, 8 New Single Family (average cost \$165,343), 49 Residential Remodel (average cost \$14,934), 1 New Commercial (average cost \$536,646, 8 Commercial Remodel (average cost \$261,204), 0 new Multi- family.

Electric Customer Service—Payments—38,071, Collections—\$8,147,706.

Code Enforcement—Assigned calls—82, Citations—15, Violation Notices—203, Vehicles Tagged—47, Lots Posted—17, Signs Removed—12, Structures Inspected—11, Rental Inspections—17, Food Service Inspections—12, Houses Demolished by city—0, Houses Demolished by owner—0, Vacant Lots Cleaned—29, Lots with Structures Cleaned—8, Vacant Houses Secured—0, Vacant Lots Mowed—29, Lots with Structures Mowed—8. To see an individual ID/Permit, click on the person's name. All licensed door to door peddlers are **required to have the ID issued by the City Clerk's Office with them at all times.**

Currently, we have NO permitted door to door solicitors.

All North Little Rock Business/Privilege License/Permits will expire December 31, 2021. License holders have until March 31, 2022 to renew. Renewals after April 1, 2022 will be subject to a 25% penalty.

Renewal invoices/letters will be mailed December 30, 2021. If you do not receive a renewal by mid-January, please contact the City Clerk's Office at CityClerkOffice@nlr.ar.gov

All persons doing business of any kind within the city limits of North Little Rock are required to have a Business/Privilege License. This includes home-based such as lawn care or internet sales.

****If a business operates 1 day into the new year, it is required to obtain a business license at the full fee.****

Operating a Business in North Little Rock

If you have decided to open a business in North Little Rock (NLR), we are glad you will be a partner in the development of our wonderful city. We also want to take the time to provide some basic information for all business operators.

1. The **NLR City Council requires all persons conducting business of any kind in our city to have a current Business/Privilege License/Permit.**
2. The **NLR City Council requires all persons wishing to operate a business in our city to obtain a zoning certificate.** This ensures that the type of business to be operated corresponds with the current zoning of the location. (This applies to home-based businesses as well).
3. NLR Business/Privilege License/Permits must be renewed annually. **All License/Permits run from January 1 thru December 31.** Some new accounts opened within the calendar year may be prorated (quarterly).
4. **Hotels, Motels, Home Vacation Rentals, Restaurants and Food Trucks are also subject to an Advertising and Promotion (A&P) tax** to be collected at the point of sale and remitted monthly to the A&P Commission.
5. The majority of businesses will be **subject to the General Sales and Use Tax.**
6. The business may also be subject to certain **County taxes** and should contact the Pulaski County Assessor's Office.
7. Businesses operating in the city are **subject to inspection by the North Little Rock Fire Department** to ensure they are in compliance with the Fire Code.
8. Businesses **must have prior approval for signage** (not allowed for home-based businesses).
9. **Some businesses** (restaurants, food trucks, day cares, etc.) **may also require a State Health inspection** prior to obtaining a business license.
10. **All businesses selling alcoholic beverages** must have a **State Alcohol Beverage Control Board (ABC) License** before selling any of these products.
