Fireworks are prohibited within the North Little Rock City Limits

...Except as hereinafter provided, it **shall be unlawful for any person to possess, store, offer for sale, sell at retail, set off, ignite or otherwise explode any firecrackers or other fire works** by whatever name called within the city limits; provided that *the use of fire works for public displays shall be allowed upon the approval of the fire marshal after all of the provisions of NfiPa 1123 are met and all necessary permits have been issued.* Every such use or display shall be handled by a competent operator approved by the fire marshal and shall be of such character and so located, discharged or fired so as not to be hazardous to property or endanger any person.

...No parent or guardian of a minor shall furnish money or any thing of value to a minor for the purchase of fireworks or encourage, act in conjunction with or in any manner instigate or aid a minor in the commission of having, keeping, storing, selling, offering for sale, giving away, using, transporting or manufacturing fireworks within the corporate limits of the city. The violation of this section shall be an offense regardless of whether or not the minor shall be charged or found guilty of the offense. The commission of the offense by the minor on the property under the control or owned by the parent or guardian shall be prima facie proved that the parent or guardian aided the minor.

...The fine or penalty for violating this provision, upon conviction in municipal court shall be not less than twenty-five and 00/100 dollars (\$25.00) nor more than five hundred and 00/100 dollars (\$500.00).

...Finally, anyone caught with fireworks in the city limits will have said **fireworks confiscated and destroyed.**

The Fourth of July is a day of festive celebrations, but it can take a frightening turn for pet owners.

Fireworks and other loud noises can spook animals and cause them to run away, and big parties with lots of people going in and out can mean it's easier for cats and dogs to get loose. That's why multiple animal shelters around the country say July 4 and 5 are some of their busiest days of the year as they take in lots of found animals and deal with panicked owners searching for lost pets.

Emily Weiss, vice president of shelter research and development at the American Society for the Prevention of Cruelty to Animals, noted that celebrations throughout the summer can be dangerous for pets. "The summer months are a busy time for shelters, as many pets are at an increased risk of escape during holiday celebrations because of the crowds, loud noises, and open doors and windows," she told HuffPost in an email. "The most important thing you can do for your pet this holiday season is to be sure they have a visible ID tag with your up-to-date contact information."

Pet owners should also have their pets microchipped, she said. A microchip is a tiny ID device implanted under

the skin. If a pet is found and taken to a shelter or veterinarian, they can scan the pet for a microchip that would provide contact information on the owner, which is why it's crucial to make sure that your pet's microchip information is updated.

Dogs can get so freaked out by fireworks that they may become panicked and "do anything" to try to escape. This can include digging under, climbing over or even breaking through gates, screens, fences, windows and doors.

People SHOULD NOT bring their pets to fireworks shows. Instead, try to provide a quiet, comfortable and

secure place for the pet in the home. If people are hosting a party, they should ensure their pets are able to relax in a controlled area away from the crowd.

It is also recommended that dogs be exercised earlier in the day so they will be calmer before fireworks start.

"A tired dog is a more relaxed dog," animal trainer Nicole Ellis told HuffPost previously. She added that if your pup does run and hide within your home, you shouldn't force it to come out, which can make your pet even more distressed. Like Weiss she emphasized keeping pets at home and making sure your animal has proper ID.

It's also crucial that cats remain indoors on the holiday, cat behaviorist Jackson Galaxy told "Today." Cats have extremely sensitive hearing, which can make fireworks and other sudden, loud sounds terrifying. Galaxy recommended that owners create a cat sanctuary in a quiet room filled with comforting items, like a cat's bed and objects that smell like the cat or the cat's favorite person. If there's a lot of noise outside, it can be helpful to use a TV or radio to create a low level of distracting sound.

Why does the Fire Department Inspect Businesses?

Business inspections and pre-incident planning surveys allow fire department personnel to gather information about occupied structures **before** an emergency occurs which could assist with any of the following at the structure:

Locating and controlling a fire

Locating occupants

Determining potential hazards

Improving emergency operations

Improving both firefighter and occupant safety

During these surveys, firefighters document the following details about a structure using maps, drawings, photographs, and written notes:

Construction type

Floor plan or layout

Contents

Occupancy type

Hazardous materials storage

Special Processes

Fire detection and suppression systems

Fuel load

The ultimate purpose of the survey is to help firefighters accomplish the following goals:

Become familiar with structures in their district, their uses, and their associated hazards

Recognize existing hazards

Visualize how standard tactics may or may not apply in various occupancies

Develop new tactics if necessary

Determine if occupants have disabilities or medical conditions that may prohibit self-evacuation

Determine if there are occupants with language barriers that may require translators

If code violations are discovered during the survey, the fire officer may request that the owner/occupant correct the violation or may report the problem to the Fire Marshal's Office.

The North Little Rock Fire Marshal's Office is comprised of three sworn fire officers that are law enforcement certified along with fire code certification. They can issue citations and execute search warrants.

The annual business inspections also assist with North Little Rock maintaining its **ISO Class 1** (one) rating, which is the highest rating a fire department can achieve. It is an insurance rating which measures overall fire safety for a municipality. This assists in lowering insurance rates for homeowners and businesses.

Highlights from some City Departments



Mayor Joe A. Smith holds a monthly department head meeting. Department heads provide a report of activities, projects and accomplishments. Below are a few highlights from the last meeting (May events).

Hays Center—66 new members. 14,505 visits for the month. Activities included Craft Day, Flavors Around the World cooking class, Arkansas League of Artists Art Show, and Red Hot Hays Honey's appearance on KATV Good Morning Arkansas. Transported Public Senior Housing residents to medical appointments and grocery store, Bean Bag Baseball teams traveled to Little Rock, Jacksonville and Lonoke for "away games. Mayor's Office of Volunteer Services volunteers logged 1,289 hours.

Electric Customer Service—Direct contact—inside teller payments, 20,150 Drive-thru payments, 8,764. Total payments received: 52,945 (Electric—40,130, CAW 7,995, Centerpoint 4,820).

Sanitation—Collected and disposed of 2,472.17 tons (4,944,340 lbs) of household garbage/rubbish. Yard Waste crews collected and disposed 114 loads; 3,167.4 cubic yards of green waste. Picked up 82 tires. Issued 79 Sanitation/Code violation notices, 11 citations.

Traffic Services—approved 76 barricade applications for permits. Repaired or replaced 228 signs and posts, marked 10 city vehicles with logo, 79 Arkansas One Call location requests.

Police—April numbers show decreases in the following areas: Robberies—down 7%, Property crime down—20%. Burglary/Breaking and Entering of Buildings and Vehicles showed significant decreases. However, these may increase during the summer months. Residents are encouraged to continue to lock their vehicles and homes, close garage doors and not leave valuables in automobiles. The Police Athletic League was recognized for their work in the community and Ken Abel was recognized Volunteer of the Year! NLRPD Honor Guard was asked to lead the State Police Memorial at the State Capitol. 3rd Annual Summer Youth Camp underway.

Diabetes and driver safety

There are very strict laws for drivers with diabetes, especially those with a commercial drivers license (CDL). The American Diabetes Association offers literature explaining restrictions and exemptions on this topic and many more tips on this subject.

Diabetes is a disease in which the body's ability to produce or respond to the hormone insulin is impaired, resulting in abnormal metabolism of carbohydrates and elevated levels of glucose in the blood and urine.

There are four types of diabetes:

- Type 1 is a chronic condition in which the pancreas produces little or no insulin
- Type 2 is a condition that affects the way the body processes blood sugar
- Gestational diabetes is defined as blood sugar elevation during pregnancy
- Pre-diabetes is not technically diabetes, but some experts believe it is a first step to Type 2 diabetes. It is noted by blood sugar levels that are too high to be considered normal but not yet high enough to be in the range of normal diabetes.

If a driver of a personal vehicle or commercial vehicle has any of these conditions, it can be a safety concern.

How can diabetes impact driving?

For many people with diabetes, driving is a part of daily life. The good news is that most people with diabetes can safely drive motor vehicles. However, in some situations, symptoms or complications of diabetes might make it difficult to drive safely.

Symptoms of diabetes that are of concern include: numbness in limbs, increased urination, weight loss, increased appetite, blurry vision, itchy and dry skin, unexplained fatigue,

excessive thirst, slow healing of cuts or bruising, irritated gums, dry mouth, frequent yeast infections, dark patches of skin, erectile dysfunction, headaches, nausea, vomiting, unsteadiness, and weakness. As you read through this list of symptoms, it is easy to see how any of these symptoms could result in limitations of driving.

There are some ways to overcome the diabetes dilemma and driving. The Department of Transportation offers an exemption to an insulin-dependent drive for a chance to drive; however, state agencies make the final decision since they issue the commercial driver's license. If you are a Type 2 diabetic and do not use insulin, you do not have to apply for the exemption. State driving laws can impact non-commercial drivers, and this may involve a medical evaluation and documentation from a medical professional. In years past, a CDL holder being treated with insulin must have driven a commercial vehicle for the previous three years before applying for and qualifying for an exemption. This was a poorly written regulation and limited many drivers from being employed.

Diabetes is an illness that impacts millions of Americans and can seriously impact their lifestyle and health though it is treatable. Research and new medications are helping to make significant changes in eliminating limitations and stigmas. Employees with diabetes should notify their employer about having diabetes so that any emergency situa-

tion that arises due to insulin issues can be handled appropriately at the workplace.

Display of Address of all Residential and Commercial Businesses

Did you know the City of North Little Rock requires the display of street numbers on both residential and commercial buildings? Why you ask? It is beneficial to the residents and persons traveling in the city to be able to rapidly located and identify a location. Police, Fire and Ambulance workers need to be able to quickly locate the address of a potential health or fire concern in the event of an emergency.

Property owners are required to display the street number on the building in a fashion to allow identification of the property from the nearest right-of-way. The numbers should be no less than 3" in height for residential structures and 6" in height for non-residential (commercial) structures. The color of the numbers needs to contrast the background to promote visibility.

Street address painted on a curb shall not be sufficient to meet this requirement (and therefore, are not required by the city).

Question: *If someone comes to my home selling Newspaper subscriptions, are they required to have a door-to-door peddlers permit?*

Answer: Yes. **Anyone** going door to door in the North Little Rock City Limits is required to have a peddlers permit and ID issued by the City Clerk's Office. Other examples include newspapers, pest control, alarm systems, home improvements, etc.

Reminder to residents:

If someone comes to your door, you do not have to answer or let them in. If someone comes to your door and makes you uncomfortable please call the police. If someone comes to your door and is unable to produce an ID issued by the City of North Little Rock City Clerk and Treasurer's Office (similar to the example on this page), please call 501-758-1234.

In all cases, if you call please provide a description of the person, location and vehicle description and license number if possible. You can also call the North Little Rock City Clerk/Treasurer's Office Monday through Friday 8:00 a.m.—4:30 p.m. to verify any business license or peddlers permit in our city at 501-975-8617.

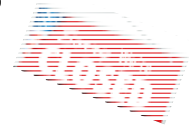
