SCOPE OF WORK

The project consists of removing the existing debris from the forebay area of the Murray Hydroelectric Generation Facility (Murray Hydro) located on the Arkansas River.

- 1. Dredging operations utilizing a floating (barge) dredge and discharge through an overland pipeline to two remote areas intended for permanent fill.
- 2. Containment berms and return flume structures for both fill areas.
- 3. Grading, restoration of vegetation, stormwater control and other ancillary items.
