AN ORDINANCE VACATING AND ABANDONING A CERTAIN UNUSED EASEMENT ON PROPERTY LOCATED BETWEEN 1600 AND 1606 WATERSIDE DRIVE IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES, was read. On the motion of Council Member Ross and seconded by Council Member Taylor, and by consent of all members present, the readings were suspended (8/0). Council Member Ross said the plan is to replat the two lots into one. The applicant, Mr. Thomas Spears said the intent is to build a new home across the property line. There are existing easements that had to be vacated and abandoned. Mr. Spears family has owned the two lots for some time. Mayor Hartwick convened a public hearing. There being no one present wishing to be heard, the public hearing was adjourned. On the motion of Council Member Ross and seconded by Council Member Hamilton and the roll having been called and all members present having voted in the affirmative, the ordinance was unanimously adopted (8/0). Emergency clause unanimously adopted (8/0). (requested by: Thomas Spears trustee of the Spears Living Trust)

PUBLIC COMMENT

Council Member Hamilton said the North Little Rock Electric Department is working hard to get the largest number of customers' power back on (following significant damage due to high winds over the weekend). The department has been able to restore power to 22,000 customers within the past 24 hours. There are still 6,000 customers without power. Council Member Baxter said the city has had a stream of weather related events recently. The City of North Little Rock was recently recognized by the Wellness Council of America and received the Bronze Award for how the city has approached wellness in our community. He commended Fit2Live Director LaKaisha Shelby for her efforts. Mayor Hartwick said Governor Sarah Huckabee Sanders is considering an Emergency Declaration due to the widespread wind damage across the state. He said we had about 15,000 North Little Rock Electric customers without power following the March 31, 2023, tornado. The wind damage from this past weekend left over 27,000 customers without power. Mayor Hartwick thanked the crews from

Jonesboro, Bentonville and Conway who are in North Little Rock helping with restoration. Council Member Baxter said the city should be able to pick up wind debris. Mayor Hartwick said over 12,000 trees were lost in Burns Park (due to the Marcy 31, 2023 tornado). This provides an opportunity for future growth in the park. Teams are playing ball, golf is up and running as is the Tennis Center. Disc Golf will take a little while longer to get back up. Soccer field parking lots were used for tornado debris storage and mulching. This will delay the use of those fields until early Fall. Mayor Hartwick thanked all of the city employees for their efforts. Mayor Hartwick reminded the public of the upcoming Independence Day holiday. Council Member Ross reminded everyone fireworks are not allowed in the city.

There being no further business to come before the Council, and on the motion of Council Member Ross and seconded by Council Member Hamilton, and by consent of all members present, the meeting was adjourned at 6:28 p.m. (8/0), until the next regularly scheduled meeting to be held on Monday, July 10, 2023, at six o'clock p.m. in the City Council Chambers in City Hall, located at 300 Main Street, North Little Rock, Arkansas.
