WHEREAS, the Murray Hydroelectric Plant ("Hydro Plant") is in need of an emergency replacement battery bank; and

WHEREAS, due to time restraints, it is not feasible to follow bidding procedures; and

WHEREAS, New Venture Telecommunication Services, Inc., 4266 East 43rd Street, North Little Rock, Arkansas 72117, ("New Venture") provides equipment and annual maintenance for the Hydro Plant, and has the replacement in stock; and

WHEREAS, the cost of the replacement is Sixty Three Thousand Two Hundred and 00/100 Dollars (\$63,200.00) (see Quote attached hereto as Exhibit A).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:
