**A RESOLUTION WAIVING FORMAL BIDDING REQUIREMENTS AND AUTHORIZING PAYMENT TO RUSSELL CHEVROLET FOR THE PURCHASE OF A VEHICLE FOR THE NORTH LITTLE ROCK ELECTRIC DEPARTMENT; AND FOR OTHER PURPOSES.**

WHEREAS, Ark. Code Ann. § 14-58-303 requires City purchases exceeding the amount of \$35,000 to follow statutory procedures of local advertisement and opening of sealed bids which may only be waived in exceptional situations where bidding is deemed not feasible or practical; and

WHEREAS, the City of North Little Rock (“the City”) is in need of a vehicle for the Electric Department (“NLRED”); and

WHEREAS, there is a shortage of vehicles due to the COVID-19 pandemic, and no vehicles are available through the state contract or the City’s cooperative purchasing program memberships; and

WHEREAS, Russell Chevrolet, 6100 Landers Road, Sherwood, Arkansas 72117, has a vehicle available for the cost of Forty Four Thousand Eight Hundred Ninety Nine and 00/100 Dollars (\$44,899.00) (see Quote attached hereto as Exhibit A).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That formal bidding is hereby waived in connection with the purchase of a vehicle from Russell Chevrolet for a total amount of Forty Four Thousand Eight Hundred Ninety Nine and 00/100 Dollars (\$44,899.00).

SECTION 2: That the cost of the vehicle shall be paid from the 2023 Electric Department Budget.

SECTION 3: That the provisions of this Resolution are hereby declared to be severable, and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 4: That this Resolution shall be in full force and effect from and after its passage and approval.
