ORDINANCE NO.

AN ORDINANCE APPROVING FEE IN-LIEU OF SIDEWALK CONSTRUCTION FOR CERTAIN REAL PROPERTY LOCATED AT 7001 JOHN F. KENNEDY BOULEVARD IN THE CITY OF NORTH LITTLE ROCK, PULASKI COUNTY, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, Zachary Mills of Toth & Associates, 1550 East Republic Road, Springfield, Missouri 65804, has requested a fee in-lieu of sidewalk construction for certain real property located at 7001 John F. Kennedy Road (see letter and application attached respectively as Exhibit A and B); and

WHEREAS, the City Engineer has reviewed the request and recommended that the City Council approve the fee in lieu of sidewalk construction; and

WHEREAS, it is in the best interests of the City that the applicant pay the fee in the amount of One Thousand Nine Hundred Twenty and 00/100 Dollars (\$1,920.00).

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the request for fee in-lieu of sidewalk construction is hereby approved for the subject real property located at 7001 John F. Kennedy Boulevard, being more particularly described as Lot 1, Block 300 of the Indian Hills Addition to the City of North Little Rock, Pulaski County, Arkansas (see maps attached hereto as Exhibit C).

SECTION 2: That the fee, in the amount of \$1,920.00, shall be paid to the Ward 4 account for fees in-lieu of sidewalk construction.

SECTION 3: That the provisions of this Ordinance are hereby declared to be severable and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 4: It is hereby found and determined that it is in the best interests of the City of North Little Rock to approve the fee in lieu of sidewalk construction, and the immediate passage of this Ordinance is necessary in order to insure the proper and orderly growth of this land and the City, and being necessary for the immediate preservation of the public health, safety and welfare; THEREFORE, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect from and after its passage and approval.

Please accept this letter for approval of a fee in-lieu of sidewalk for the proposed 7-Brew located at 7001 JFK Blvd. Construction of the sidewalk is not feasible due to the existing grade within the right of way from the site to the street. On the east side of the site there is an existing slope of ~25%. Additionally, there is no sidewalk connectivity along the north side of JFK Blvd for approximately 400' in either direction of the site. A fee in lieu of sidewalk has been requested using an installed cost of \$8.00/S.F. The estimated length of 5' sidewalk between driveway approaches is 48'. The proposed fee in lieu of sidewalk is \$1920.00.



