## RESOLUTION NO.

A RESOLUTION REPEALING RESOLUTION NO. 7402, WHICH CONDEMNED PROPERTY LOCATED AT 1516-1516 1/2 PHYLLIS STREET IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS; AND FOR OTHER PURPOSES.

WHEREAS, on February 23, 2009, the North Little Rock City Council ("the City Council") passed Resolution No. 7402, whereby certain real property located at 1516-1516 1/2 Phyllis Street (owned by Bobby Anita Jenkins and Juanita Virginia Jenkins) was declared a nuisance and condemned; and
