The regular meeting of the North Little Rock City Council was preceded by a Public Meeting. The topic was to discuss the proposed 2024 City of North Little Rock and North Little Rock Electric Department Budgets.

Mayor Terry C. Hartwick convened a public meeting at 5:00 p.m. to discuss the 2024 proposed North Little Rock City Budget. Members of the audience were asked to sign up to speak prior to the meeting convening. Those persons were called in the order they signed in.

Mr. Will Hogg is Treasurer and Vice Chairman for Seis Puentes. The program has been in the City of North Little Rock over 20 years and provides resources to the Hispanic and Latino communities. Over 500 back packs have been given annually to school age children in need, thousands of meals have been prepared and shared, weekly ESL classes, financial classes, issued over 750 ID (cards) through a partnership with the city. The organization assists non-English speaking parents when enrolling their children in the (North Little Rock) School District and have also worked with small businesses in getting their city business license, permits, etc. The (2020) Census estimates 10 percent of North Little Rock's population to be Hispanic or Latino. Seis Puentes has purchased an abandoned property on MacArthur Drive in North Little Rock and look forward to moving to the location in 2024. Their annual operating budget is about \$150,000.00. The building renovation project will be around \$300,000.00. Seis Puentes requested \$150,000.00 in the 2024 city budget. Ms. Allison Allred has been an attorney in North Little Rock since 1997. She is a member of the Seis Puentes Board of Directors and asked other board members to stand. She referenced workers who were present in the city to rebuild following the March 31, 2023 tornado, the majority were Hispanic. Executive Director Raul Fernandez was also present at the podium but did not speak. Ms. Sarah Ruple is the Chief Development Officer for the Arkansas Food Bank. She said they are the largest hunger relief agency in the state. They appreciate the consistent, reliable support from the city. In 2022, the USDA ranked Arkansas first in food insecurity in the U.S. with a rate of 16.6%. Funding from the city supported 17 food pantries in 2023 within the city. Each of the food pantries is a 501c3. Funding is used to acquire more food and build the capacity of their pantry. Ms. Bailey Faulkner is the Executive Director of the Ozark Mission Project. Ms. Margie Evans lives in the Dixie Addition. She said funds from the Ozark Mission Project helped put a much needed new roof on her house. They also built a ramp to her porch and were very nice. She also said the volunteers have been doing good work in the neighborhoods. Ms. Grace Mayweathers said she needs a new roof. She has applied several times. Her insurance agency referred her to different organizations but they were either outside the North Little Rock area or had exhausted funds. She applied for a roof through the Ozark Mission Project and is on the waiting list. Ms. Liza Godwin is with the Ozark Mission Project. She and her husband Hank have been involved in a roof replacement program in North Little Rock. The three \$100,000.00 installments they have received allowed the opportunity to provide a service which allowed residents to stay in their home and retain homeowners insurance. Mrs. Godwin referenced previous comments regarding the use of funds and the benefit to the residents. They are hopeful that the amount provided by CARES Act Funds will be continued through 2024. Their request is for at least \$100,000.00 in 2024. They

have \$15,000.00 remaining which has been allocated to be spent during their Summer Mission Week when students and adults from Arkansas and surrounding states will come to the city and perform tasks like yard work, pressure washing, house painting, and larger tasks such as construction of porches and wheelchair ramps. In the past, there have been families who have to call the Fire Department for assistance in moving a family member from their home just to get to a doctor's appointment. If there are funds leftover following Mission Week, they are used to provide emergency services during the off-season such as assisting stroke or amputee patients. In the past two (2) months, they have built four (4) wheelchair ramps and provided one (1) set of safe steps with handrails in the Levy, Rose City and Baring Cross neighborhoods. Ms. Godwin said they are thankful for the funds and support in the past. Mr. Michael Marion spoke on behalf of ACT (Argenta Community Theater) (I and II). He said he is the General Manager of Simmons Bank Arena. He is the chairman of ACT board and thanked the city for past financial support. Over 25,000 people visit the theater annually for various events. The theater has been a great addition to the downtown area and provides an economic impact. Mrs. Allison Courtney is Director of Development for ACT. The program began in 2012 with 50 students. There are now 2,349 students. In the past year, they opened ACT II which is an education facility and are looking at another expansion in the future. Other programs (Ballet Arkansas, The REP, and the Arkansas Museum of Fine Arts) have reached out to partner with ACT. Ms. Courtney asked for continued support and added there are not a lot of places for students to enjoy the arts. She said there are 60 schools in Little Rock, North Little Rock and Pulaski County with no performing arts programs. Mr. Lane Harbor is Deputy Director and Chief Financial Officer for the Arkansas Museum of the Arts. The city has supported the Museum of the Arts for at least 21 years. The museum is located in Little Rock but serves the whole state with the majority of patrons being from central Arkansas. At the time of their application, they had 70,000 visitors to the new museum which opened in April (2023). The number of visitors today is up to 90,000 with 15.2 percent from North Little Rock. Mr. Harbor added 16 percent of their board members are from North Little Rock. Mayor Hartwick serves as an Exofficio member of the board. The museum is open free to the public and there are a lot of free programs open for ages toddler through adult. Some services with fees include their theater and art school classes. The Arts Museum has 196 employees with 16 percent of them residing in North Little Rock. They also have a Teacher's Advisory and Teen Advisory Board with members from the city. Mayor Hartwick referenced other organizations who did not sign in and asked if those representatives would like to speak. Ms. Cindy Doramus, Chief Executive Officer of the Boys and Girls Club of Central Arkansas referenced the (Jim) Wetherington Boys and Girls Club located in North Little Rock. The site is currently undergoing refurbishing and upgrades. Youth are in the center daily. The focus is on academics, healthy lifestyles, leadership skills, job skills, and readiness. The facility also has basketball and other sports programs. Participants range from six to eighteen years of age. The goal is to assist youth in graduating on time and going on to secondary education or entering the workforce with job skills. Ms. Doramus said they offer a virtual learning program which includes at least 100 vocations (including nursing, hospitality, HVAC, welding, etc.). Ms. Errin Stanger, Director of the Arkansas Innovation Hub, which Arkansas's first and largest Makers space (located in Argenta). The focus is on S.T.E.A.M. education for youth and adults. She estimated they will serve 10,000 youth in

2023. Funding from the city has allowed them to offer over 371 scholarships to North Little Rock students in Elementary, Middle and High School in 2023. They also offer memberships with 37 percent of those members living in North Little Rock. Earlier this year, following the March 31 tornado, The Innovation Hub closed and designed a "North Little Rock Strong" logo then provided Tshirts to city staff. Member went into affected neighborhoods and provided food and activities for youth. Funding allowed youth affected by the tornado to come into the facility and participate in programs at no cost. Ms. Stanger said they are the Microsoft Tech Spark recipient for funding this year and credited the city's support as a factor. She said their Maker 48 program will be included in four upcoming television episodes to be aired on This Old House. Mr. Kelly Bass is the Chief Executive Officer for the Museum of Discovery. He had been aware of the city's support of (various non-profit) organizations. This is his first year to request funding. The Museum is growing and located in central Arkansas and was named the 6th best museum of its type in the U.S. in a USA Today readers' poll. They had visitors from across the U.S. As of today, 7,561 North Little Rock residents and 6,265 North Little Rock school children have visited. North Little Rock is their second largest market. Staff have been working in North Little Rock schools through outreach programs. Saturday will be the unveiling of 78 new exhibits in the science lab and dynamic earth galleries. The cost to run the museum has increased. Payroll doubled in the past 10 years ago. Council Member Robinson asked Mr. Bass how much he was requesting. Mr. Bass said \$100,000.00. Mr. Chris Kent, Executive Director Argenta Downtown Council (ADC) said they have a Clean, Green and Safe Program which keeps the downtown streets clean downtown. Volunteers just planted 20,000 new tulip bulbs for the annual spring bloom. ADC has hosted 26 free family-friendly events which included the Argenta Throw Down, Art Walks, and six (6) Argenta Vibe concert series. Mr. Kent referenced the Safety Ambassador Program which has been in place for 12 years and frees up police officers to work in other areas. The ambassadors help youth and adults get to and from their vehicle safely. ADC also works closely with (North Little Rock) Economic Development in creating a space where businesses will thrive. A new restaurant will opening across the street from City Hall and will bring an additional economic impact to the area (the business will have around 35 employees with an average income of \$40,000.00 a year). Council Member Ross asked the budget request again include the Mid-City area. Mr. Nick Leopoulus, Thea Foundation Executive Director, thanked the city for past support. He said they have helped 34 schools in the (North Little Rock) District this year and have hosted several events featuring North Little Rock students. Council Member Ross asked about their events. Mr. Leopoulus said they have monthly art exhibits and the current featured artist is Jeff Horton. He said THEA is open from 9 a.m. to 5:00 p.m., Monday through Thursday, and groups can schedule visits. North Little Rock Police Athletic League Director Officer Shelby Hunter said he grew up on the ball fields at PAL. He has been coaching youth through PAL since 2010 and the past few years have been great. Funding provided by the city was used to renovate the Rose City Ball Park, rebuild bleachers, and build new batting cages. There are 600 kids participating in the baseball / softball program. Another 200 participate in football and there is also a Cheer program with 50 youth participants. Renovations for 2024 include plumbing and refurbishment of North Heights. He thanked the council for their continued support. Council Member Ross said a lot of the work is done by volunteers. He said the

Rose City field is now turf as a result of obtaining the old turf from Dickey Stephens Ball Park. Council Member Hamilton asked how long the city had donated funds to PAL. Chief of Staff Mike Davis said the program has been in existence since the late 1980's. The city has been providing funding since at least 2001. Mr. Steven Morris, Program Director for River City Ministry, thanked the city for their support in 2023. The funds provided the opportunity to hire a cook and get their showers working. They were also able to purchase walk-in coolers/freezers which has aided in providing services. They serve homeless people in this area and a lot of low income people in North Little Rock. The numbers are several hundred and a lot more have become homeless as a result of the pandemic. Mr. Morris said they used to serve an average of 100 to 150 lunches. The numbers are now at 250. Council Member Ross asked how much funding the city recently allocated to River City. Chief Financial Officer Ember Strange said it was \$300,000.00. Mr. Mark Dale is President of the Board of Directors for The Van also known as The One, Inc. He thanked the city for \$50,000.00 donated last year for the Jericho Way. Funds were used to assist with the needs of the unsheltered population in North Little Rock and Little Rock area. Funds provided last year helped pay for fuel and supplies. They were able to purchase a larger commercial ice maker which provided the opportunity to provide ice to "unsheltered" camps. They have a shower trailer that needs repairs and need commercial washers and dryers. Council Member Robinson asked Mrs. Strange about the proposed numbers in the budget for Special Projects as some of the allocations were returned to pre-COVID prices. She said everything increased in price since the beginning of the pandemic. Mayor Hartwick reminded everyone this is not a final budget. There being no one else wishing to be heard, Mayor Hartwick adjourned the public hearing.
