The regular meeting of the North Little Rock City Council scheduled for Monday, December 11, 2023, was called to order at 5:59 p.m. by the Honorable Mayor Terry C. Hartwick.

Council members had the option of attending the council meeting in person or participate virtually. The Council Chambers were open to the public.

The roll having been called and the following Council Members answered to their names: DEBI ROSS, NATHAN HAMILTON, LINDA ROBINSON, STEVE BAXTER, RON HARRIS, VINCE INSALACO, III, and CHARLIE HIGHT (7/0). Council Member MAURICE TAYLOR arrived after the meeting convened at 6:01 p.m. Chief Deputy City Clerk and Treasurer Katelyn Thomas, Deputy City Clerk/Treasurer Talor Shinn, and City Attorney Amy Fields were also present.

The prayer and pledge of allegiance were led by IT Director John Barber.

On the motion of Council Member Insalaco and seconded by Council Member Hight, and by consent of all members present, the minutes from the North Little Rock City Council meeting held Monday, November 27, 2023, were approved, accepted and filed as prepared by City Clerk Diane Whitbey (7/0).

Note: Council Member Taylor entered the chambers.

On the motion of Council Member Baxter and seconded by Council Member Hamilton, and by consent of all members present, communications #1 and 2 were accepted and filed (8/0).

PRESENTATIONS

Mayor Hartwick invited Mr. Kal Makan to come forward. Mr. Makan said he would develop a highend hotel that will be part of the Hilton Hotel chain. Tempo by Hilton is a new brand. The hotel coming to North Little Rock will include Argenta in the name. Council Member Harris asked how many stories would be in the building. Mr. Makan said between eight and nine with a rooftop element. He referenced (the height of) the Hampton Inn in Little Rock. The number of guest rooms could be 120. Mr. Makan asked for the council's approval of the branding if they move forward and said that all proceeds with the current timeline (closing on the land, submit plans, etc.) will take about 18 months. The hotel could open in 2025. Thomas Engineering is working on parking. City Attorney Fields said part of the real estate contract is to have an approved development plan prior to closing. On the motion of Council Member Taylor and seconded by Council Member Hamilton, and by consent of all members present, a voice/visual (hands-raised) vote was taken in support of the proposal as referenced (8/0).

PUBLIC COMMENT

Mr. Rocky McDaniel said one of the Downtown Argenta Ambassadors recently lost his job. The employee (name not provided) was a good person, had an excellent personality, had been doing the job for over 10 years and was always helpful to anyone who needed it. The city already funds the program and should be in charge of it and put the employees under the police department. The Argenta Downtown Council has its own funding from taxes collected from businesses in the area. Mr. McDaniel asked the city to stop providing funding. He said this is the city's business. Mr. Bobby Taylor continues to have issues with a house at 4605 Boyer. The owner has been in North Little Rock Municipal Court on (code enforcement issues included) infestations from rodents and insects (rats and roaches). Mr. Taylor has reached out to local media representatives who suggested he contact (North Little Rock) Code Enforcement. Mr. Taylor said he worked hard to make the payments on his property and keeps it up. Mr. Taylor also referenced (North Little Rock) Wastewater hauled gravel into an area at Prothro from Rogers to Boyer. Gravel fell onto the street and needs to be cleaned up. Ms. Mary Anne Bradfield and Ms. Gabriela Garcia with the U.S. Small Business Administration referenced storm damage in Pulaski County (North Little Rock) June 25 and 26, 2023. FEMA was not able to make a declaration in this area. The Small Business Administration does have aid available for physical damage for homeowners, renters, businesses, private non-profits, and small ag coops. There are also funds available for economic (operational) costs. They provide low interest, long-term loans with no payments or interest charged the first year. For homeowners, the rate is as low as 2.5% for 30 years. This helps bridge the gap between insurance and costs. Mayor Hartwick said the next City Council meeting will be held Wednesday, December 27, 2023, at 5:00 p.m. Mayor Hartwick thanked the 900 city employees for their service and wished everyone a Merry Christmas.
