## ORDINANCE NO. \_\_\_\_

AN ORDINANCE GRANTING A SPECIAL USE TO ALLOW A TATTOO PARLOR IN A C6 ZONE FOR CERTAIN REAL PROPERTY LOCATED AT 112 MAIN STREET IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, application was duly made by Joshua Chambers, 1742 Lilac Circle, Little Rock, Arkansas, seeking a Special Use to allow a tattoo parlor in a C6 zone located at 112 Main Street, which application was duly considered an approved (7 affirmative votes; 2 absent) by the North Little Rock Planning Commission at a regularly scheduled meeting thereof held on December 12, 2023.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That a Special Use is approved to allow a tattoo parlor in a C6 zone located at 112 Main Street in the City of North Little Rock, Pulaski County, Arkansas, being more particularly described as follows:

LOT 4, BLOCK 11 OF ARGENTA ADDITION TO THE CITY OF NORTH LITTLE ROCK, PULASKI COUNTY, ARKANSAS (See maps attached hereto as Exhibit A.)

SECTION 2: That this Special Use shall be subject to the following:

- 1. Hours of Operation: Tuesday Thursday, 2:00 pm to 10:00 pm; Friday Saturday, 2:00 pm to midnight.
- 2. Meet the requirements of the Arkansas Department of Health for Body Art Establishments.
- 3. Any structures located on the lot shall meet all applicable Federal, State, County, and City requirements and codes.
- 4. Applicant shall meet all applicable Federal, State, County, and City requirements
- 5. The Planning Department shall perform an inspection to confirm all requirements of the approval have been met.
- 6. Applicant/owner understands that failure to comply with these conditions may result in loss of the Special Use and/or loss of Business License and/or removal of Electric Power Meter.

SECTION 3: That all ordinances or parts of ordinance in conflict herewith are hereby repealed to the extent of the conflict.

SECTION 4: That the provisions of this Ordinance are hereby declared to be severable and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 5: It is hereby found and determined that the special use as described herein is compatible with other businesses in the area and is immediately necessary in order to insure the proper and orderly growth and development of this land and of the City of North Little Rock, Arkansas, and being necessary for the immediate preservation of the public health, safety and welfare, THEREFORE, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect from and after its passage and approval.
