### RESOLUTION NO.

A RESOLUTION WAIVING FORMAL BIDDING REQUIREMENTS AND AUTHORIZING PAYMENT TO GENESIS DATACOM FOR THE PURCHASE AND INSTALLATION OF CAMERAS FOR THE NORTH LITTLE ROCK STREET DEPARTMENT; AND FOR OTHER PURPOSES.

WHEREAS, Ark. Code Ann. § 14-58-303 requires City purchases exceeding the amount of \$35,000 to follow statutory procedures of local advertisement and opening of sealed bids which may only be waived in exceptional situations where bidding is deemed not feasible or practical; and

WHEREAS, the City of North Little Rock ("the City") uses the Qognify/Ocularis video monitoring system to provide continuous surveillance of its properties; and

WHEREAS, the North Little Rock Street Department needs to be integrated into the system and requires the replacement of current cameras that are incompatible with the Qognify/Ocularis software; and

WHEREAS, Genesis Datacom, 13008 Lawson Road, Little Rock, AR 72210, is a sole source vendor approved to install Qognify/Ocularis software, and the only vendor able to properly configure the cameras; and

WHEREAS, the cost of the purchase and installation of the cameras totals Forty Thousand Seven Hundred Forty and 00/100 Dollars (\$40,740.00) (see Quotes attached collectively hereto as Exhibit A.)

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That formal bidding is hereby waived in connection with the purchase and installation of the cameras from Genesis Datacom for a total amount of Forty Thousand Seven Hundred Forty and 00/100 Dollars (\$40,740.00).

SECTION 2: That the cost of the cameras shall be paid from the 2024 IT Department Budget.

SECTION 3: That the provisions of this Resolution are hereby declared to be severable, and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 4: That this Resolution shall be in full force and effect from and after its passage and approval.
