A RESOLUTION AMENDING RESOLUTION NO. 10495, WHICH WAIVED FORMAL BIDDING REQUIREMENTS AND AUTHORIZED PAYMENT TO DANA SAFETY SUPPLY, INC. FOR THE PURCHASE OF TEN VEHICLES FOR THE NORTH LITTLE ROCK POLICE DEPARTMENT; AUTHORIZING PAYMENT TO DUVAL MOTORS; AND FOR OTHER PURPOSES.

WHEREAS, Ark. Code Ann. § 14-58-303 requires City purchases exceeding the amount of \$35,000 to follow statutory procedures of local advertisement and opening of sealed bids which may only be waived in exceptional situations where bidding is deemed not feasible or practical; and

WHEREAS, on February 27, 2023, the City Council adopted Resolution No. 10495, waiving formal bidding requirements and authorizing payment to Dana Safety Supply, Inc. for the purchase of ten vehicles for the North Little Rock Police Department (“NLRPD”) for a total cost of \$662,325.84; and

WHEREAS, the City of North Little Rock (“the City”) is in need of ten (10) vehicles for the Police Department (“NLRPD”); and

WHEREAS, by virtue of a mistake on the part of the sales representative, the quote should have come from Dana Safety Supply’s parent company, Duval Motors (see email attached as Exhibit A); and

WHEREAS, the previous resolution should be amended to provide for payment to the proper entity.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That Section 1 of Resolution No. 10495 is hereby amended as follows:

SECTION 1: That formal bidding is hereby waived in connection with the purchase of the vehicles from ~~Dana Safety Supply, Inc.~~ Duval Motors for a total amount of Six Hundred Sixty Two Thousand Three Hundred Twenty Five and 84/100 Dollars (\$662,325.84).

SECTION 2: That the provisions of this Resolution are hereby declared to be severable, and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 3: That this Resolution shall be in full force and effect from and after its passage and approval.
