A RESOLUTION WAIVING FORMAL BIDDING REQUIREMENTS AND AUTHORIZING PAYMENT TO MCLARTY FORD FOR THE PURCHASE OF A VEHICLE FOR THE NORTH LITTLE ROCK ADMINISTRATION DEPARTMENT; AND FOR OTHER PURPOSES.

WHEREAS, the City of North Little Rock ("the City") is in need of a vehicle for the Administration Department; and

WHEREAS, there is a shortage of vehicles due to supply chain issues, and no vehicles are available through the state contract or the City's cooperative purchasing program memberships; and

WHEREAS, Mark McLarty Ford, 4400 Landers Road, North Little Rock, Arkansas 72117, has a vehicle available for the cost of Thirty Eight Thousand Four Hundred Ninety Five and 00/100 Dollars (\$38,495.00) (see Quote attached hereto as Exhibit A).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That formal bidding is hereby waived in connection with the purchase of one vehicle from Mark McLarty Ford for a total amount of Thirty Eight Thousand Four Hundred Ninety Five and 00/100 Dollars (\$38,495.00).

SECTION 2: That the cost of the vehicle shall be paid from the Sales Tax Capital Improvement Fund.

SECTION 3: That the provisions of this Resolution are hereby declared to be severable, and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.
