## RESOLUTION NO.

A RESOLUTION WAIVING FORMAL BIDDING REQUIREMENTS AND AUTHORIZING PAYMENT TO HENDERSON SPECIALTIES, INC. FOR THE PURCHASE OF REPLACEMENT TRASH RACKS FOR THE MURRAY HYDROELECTRIC PLANT; AND FOR OTHER PURPOSES.

WHEREAS, Ark. Code Ann. 14-58-303 requires City purchases exceeding the amount of \$35,000 to follow statutory procedures of local advertisement and opening of sealed bids which may only be waived in exceptional situations where bidding is deemed not feasible or practical; and

WHEREAS, the Murray Hydroelectric Plant ("Hydro Plant") is in need of replacement trash racks, which are used to block floating debris from entering storm water and wastewater systems; and

WHEREAS, the trash racks must be manufactured specifically for the Hydro Plant and are desperately needed to continue efficient operations; and

WHEREAS, Henderson Specialties, Inc., 2008 East 2nd Street, Russellville, Arkansas 72801, is familiar with the Hydro Plant operations and is able to complete the project quickly; and

WHEREAS, the cost of the project is One Million One Hundred Twenty Nine Thousand Two Hundred Ninety and 53/100 Dollars (\$1,129,290.53).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That formal bidding is hereby waived in connection with the purchase of replacement trash racks for the Murray Hydroelectric Plant

SECTION 2: That One Million One Hundred Twenty Nine Thousand Two Hundred Ninety and 53/100 Dollars (\$1,129,290.53) of the cost shall be paid from the 2024 Electric (Hydro) Department budget.

SECTION 3: That this Resolution shall be in full force and effect from and after its passage and approval.
