#### **PUBLIC COMMENT**

Ms. Wendy Armstrong spoke for herself and her partner Mr. James Gilbert (who was not present). She advised they were being harassed by Code Enforcement and referenced a vehicle with flat tires. She referenced a house she was trying to buy and said Code Enforcement Officer Cedric Williams had issued warnings/citations on the property which resulted in her not being able to buy the house. She said Mr. Williams then purchased the house. Ms. Deena Sticford said she has been complaining about her unit at 2503 Division Street. She has had issues for a while. She referenced multiple complaints and inspections. Mayor Hartwick asked Code Enforcement Director Felicia McHenry if her staff had been able to inspect any of the apartments. He then asked the residents/speakers to call Mrs. McHenry to schedule a time to enter their apartments. Ms. Sticford referenced a scheduled mold test at the complex and advised no one came to her apartment. Mayor Hartwick reminded the renters the property owner is in another state. Ms. Hattie Temple lives at 1726 North Locust. She said there was standing water at her unit. She said there is sewer (water) running behind McCain Mall and had photos. Mr. Tony Roy lives at 1200 John Ashley Drive. He has an issue with his drains when someone showers water and debris backs up into his tub. Mayor Hartwick asked if the owner had a plumber or someone who worked with residents when they had issues. Mr. Roy said they did not. Mayor Hartwick asked Mr. Roy if he contacted (NLR) Code Enforcement about the issue. He said he had not. Mayor Hartwick asked Mr. Roy if he would allow Code Enforcement to look in his apartment. He (Mr. Roy) said he would. Ms. Cassandra Williamson lives at 10831 Richsmith Lane. Every time it rains there is water inside her apartment. Mayor Hartwick asked Ms. Williamson if she had contacted Code Enforcement. She said she had not. She said she paid her rent on the first of May with a Money Order and was advised by the person who collects the rent the payment wasn't good. Ms. Williamson had a copy of the Money Order she purchased from Walmart. She spoke with North Little Rock Police Chief Patrick Thessing who advised her to call the North Little Rock Police Department Detective Division. Mayor Hartwick advised everyone who spoke regarding rental property issues to call Code Enforcement when they have (housing) issues. Mr. James Lucas lives at 345 Casa Court. He said a glass recycling plant is going in less than two blocks from his home. He said he found out about the plan after the fact. He said he did not receive a letter and was not aware there were (public) meetings. The plant could be hazardous and cause property values to decrease. Mr. Lucas said it wasn't fair to the neighbors. Mayor Hartwick said there were multiple meetings in the area that he and Council Members attended. He said the factory will recycle glass and produce a (light-weight) substance that can be used in road and bridge construction. Council Member Hight extended his condolences to Mayor Hartwick for the loss of his son (Ryan Hartwick).

There being no further business to come before the Council, and on the motion of Council Member Ross and seconded by Council Member Robinson, and by consent of all members present, the meeting adjourned at 6:43 p.m. (6/0), until the next regularly scheduled meeting scheduled for Monday, June 10, 2024, at six o'clock p.m. in the City Council Chambers in City Hall, located at 300 Main Street, North Little Rock, Arkansas.
