The regular meeting of the North Little Rock City Council scheduled for Monday, July 8, 2024, was called to order at 6:01 p.m. by the Honorable Mayor Terry C. Hartwick.

Council members had the option to attend the council meeting in person or participate virtually. The Council Chambers were open to the public.

SCHEDULED PUBLIC HEARING

Mayor Hartwick convened a public hearing re: O-24-50 – an Ordinance establishing the Heritage Park Circle Urban Service District No. 2 of North Little Rock, Arkansas. Mr. Bob Hardin, Attorney at Law, advised he was retained to represent the residents of Heritage Park with the statutory requirements to form an Urban Service District. He referenced petitions signed by 42 individuals who purported to be (qualified) electors within the boundaries of the district. The properties lie on Heritage Park Circle and consist of 42 lots and 41 households. The petitions were filed, notification was published of this hearing date, and notices were sent to all of the property owners, all in accordance with the statute. The purpose of the hearing was to determine if the city wanted to approve an ordinance to form the district. The statute requires 25% of the electors within the property area sign the petition. Mr. Hardin said the Pulaski County Register of Voters provided a list of all current property owners (within the area) who were shown in the records to be current voters (at an address within the area). The list included 81 individuals. 52 signatures were obtained. 42 matched those provided by Mr. Michael Razor, (Pulaski County) Voter Registration Mapping Technician. The number of qualified voters was 50% which exceeded the 25% requirement. Mr. Brooksher Banks lives at 40 Heritage Park Circle. He and his wife moved there in 1986. Heritage Park has a long-standing record of taking care of the public areas which included the entrances at McCain and from North Hills Boulevard, irrigation and plants, and the surrounding wall. The (Heritage Park) Urban Service District began approximately 15 years ago. State law included a 10 year Sunset clause. Due to the pandemic (COVID 19) the renewal was missed. They (the residents) have continued to take care of the neighborhood. Mrs. Wendy McCloud asked if signatures were collected from residents who opposed the petition. Mr. Banks said every resident was either emailed a copy of the petition or hand-delivered a petition. There were no objections. Council Member Taylor asked if there was a requirement to collect signatures in opposition of the proposal. Mr. Bank said there was not. There being no one present wishing to be heard, the public hearing was adjourned.

enforce the sign. Mrs. Martindill said she is a musician with a Master's Degree. She asked if they were being singled out or would the sign apply to everyone.
