We, the residents of West 44th Street request the City of North Little Rock Traffic Services to conduct a speed study to determine if the following street satisfies the city adopted requirements for speed hump installation:

Note:

1. Study will be conducted ONLY if 75% of the residents (fronting the affected street) support speed hump installation.
2. Speed Humps may be installed ONLY if funding is available and study results indicate that speed hump requirements are met.
3. Please make efforts to obtain signatures of ALL residents on the affected street (whether for or against).
4. Signature MUST be of the residents of the affected street.
5. Only one signature per household allowed.

While speed humps generally reduce vehicle speeds, they may also create other inconveniences such as increased vehicular noise in the vicinity of speed humps. Also, because of spacing requirements, it is possible that a speed hump, associated pavement markings and signage, as well as restricted parking may be installed adjacent to your property.
