**A RESOLUTION AUTHORIZING THE MAYOR AND CITY CLERK TO ENTER INTO MULTI-YEAR AGREEMENTS WITH MILSOFT UTILITY SOLUTIONS AND INVOICECLOUD, INC. FOR THE NORTH LITTLE ROCK ELECTRIC DEPARTMENT; AND FOR OTHER PURPOSES.**

WHEREAS, on November 12, 2024, the City Council adopted Resolution No. 10954, waiving formal bidding requirements for Milsoft Utility Solutions and its associated contractors, including InvoiceCloud, Inc., for the North Little Rock Electric Department (“NLRED”) in order to consolidate its services into a single software system; and

WHEREAS, Milsoft Utility Solutions and InvoiceCloud, Inc. each condition the use of their services on an agreement for five years; and

WHEREAS, it is in the best interests of the City and its residents to enter into multi-year agreements with Milsoft and InvoiceCloud, Inc. for their services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the Mayor and City Clerk are hereby authorized to enter into a multi-year agreement with Milsoft Utility Solutions for no more than five (5) years; with all contracts/agreements to be reviewed and approved by the City Attorney prior to execution.

SECTION 2: That the Mayor and City Clerk are hereby authorized to enter into a multi-year agreement with InvoiceCloud, Inc. for no more than five (5) years; with all contracts/agreements to be reviewed and approved by the City Attorney prior to execution.

SECTION 2: That the cost of the services shall be included in the yearly Electric Department Budget.

SECTION 3: That the provisions of this Resolution are hereby declared to be severable, and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 4: That this Resolution shall be in full force and effect from and after its passage and approval.
