**A RESOLUTION WAIVING FORMAL BIDDING REQUIREMENTS AND
AUTHORIZING PAYMENT TO EVERETT CHEVROLET FOR THE
PURCHASE OF A VEHICLE FOR THE NORTH LITTLE ROCK POLICE
DEPARTMENT; AND FOR OTHER PURPOSES.**

WHEREAS, Ark. Code Ann. § 14-58-303 requires City purchases exceeding the amount of \$42,921 to follow statutory procedures of local advertisement and opening of sealed bids which may only be waived in exceptional situations where bidding is deemed not feasible or practical; and

WHEREAS, the City of North Little Rock (the "City") is in need of a vehicle for the Police Department, Narcotics Division (the "Division"); and

WHEREAS, due to the uniqueness of the specifications needed for the Division, no suitable vehicles are available through the state contract or the City's cooperative purchasing program memberships; and

WHEREAS, Everett Chevrolet, 19236 Interstate 30, Little Rock, Arkansas 72019, can provide the vehicle for the cost of Fifty Two Thousand Seven Hundred Sixty Eight and 00/100 Dollars (\$52,768.00) (see Quote attached hereto as Exhibit A).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That formal bidding is hereby waived in connection with the purchase of a vehicle from Everett Chevrolet in the amount of Fifty Two Thousand Seven Hundred Sixty Eight and 00/100 Dollars (\$52,768.00).

SECTION 2: That the cost of the vehicle shall be paid from Equitable Sharing fund.

SECTION 3: That the provisions of this Resolution are hereby declared to be severable, and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 4: That this Resolution shall be in full force and effect from and after its passage and approval.

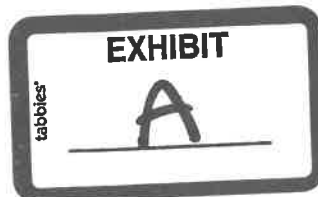
