**A RESOLUTION WAIVING FORMAL BIDDING REQUIREMENTS AND  
AUTHORIZING PAYMENT TO RED RIVER AUTO GROUP FOR THE  
PURCHASE OF ONE VEHICLE FOR THE NORTH LITTLE ROCK FIRE  
DEPARTMENT; AND FOR OTHER PURPOSES.**

WHEREAS, Ark. Code Ann. § 14-58-303 requires City purchases exceeding the amount of \$42,921 to follow statutory procedures of local advertisement and opening of sealed bids which may only be waived in exceptional situations where bidding is deemed not feasible or practical; and

WHEREAS, the City of North Little Rock (the “City”) is in need of one vehicle for the Fire Department; and

WHEREAS, there is a shortage of vehicles due to supply chain issues, and no suitable vehicles are available through the state contract or the State’s cooperative purchasing program memberships; and

WHEREAS, Red River Auto Group can provide the vehicle for the cost of Fifty Six Thousand Twenty Five and 00/100 Dollars (\$56,025.00) (see Quote attached hereto as Exhibit A).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That formal bidding is hereby waived in connection with the purchase of one vehicle from Red River Auto Group in the amount of Fifty Six Thousand Twenty Five and 00/100 Dollars (\$56,025.00)

SECTION 2: That the cost of the vehicle shall be paid from the 2026 Capital Improvement Budget.

SECTION 3: That this Resolution shall be in full force and effect from and after its passage and approval.
