

**A RESOLUTION WAIVING FORMAL BIDDING REQUIREMENTS AND AUTHORIZING PAYMENT TO RUSSELL CHEVROLET FOR THE PURCHASE OF TWO VEHICLES FOR THE NORTH LITTLE ROCK ELECTRIC DEPARTMENT; AND FOR OTHER PURPOSES.**

WHEREAS, Ark. Code Ann. § 14-58-303 requires City purchases exceeding the amount of \$42,921 to follow statutory procedures of local advertisement and opening of sealed bids which may only be waived in exceptional situations where bidding is deemed not feasible or practical; and

WHEREAS, the City of North Little Rock (the “City”) is in need of two vehicles for the Electric Department; and

WHEREAS, there is a shortage of vehicles due to supply chain issues, and there are no suitable vehicles are available through the state contract or the State’s cooperative purchasing program memberships; and

WHEREAS, Russell Chevrolet can provide the vehicles for the combined cost of Eighty Nine Thousand Nine Hundred Seven and 00/100 Dollars (\$89,907.00) (see Quotes attached hereto, collectively, as Exhibit A and B).

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:**

**SECTION 1:** That formal bidding is hereby waived in connection with the purchase of two vehicles from Russell Chevrolet in the amount of Eighty Nine Thousand Nine Hundred Seven and 00/100 Dollars (\$89,907.00).

**SECTION 2:** That the cost of the vehicles shall be paid from the 2026 Electric Budget.

**SECTION 3:** That this Resolution shall be in full force and effect from and after its passage and approval.
