**A RESOLUTION AMENDING THE 2026 BUDGET FOR THE CITY OF NORTH LITTLE ROCK TO ESTABLISH AN EVENT CENTER FUND AND BUDGET FOR THE EVENT CENTER FUND; AND FOR OTHER PURPOSES.**

WHEREAS, the City Council has found and determined that it is necessary and desirable to amend the 2026 Budget (adopted pursuant to Resolution No. 11183 on November 24, 2025) to establish an Event Center Fund and to include revenue and expenses for the Fund (See Exhibit A attached hereto).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the 2026 Budget for the City of North Little Rock should be, and is hereby, amended (see Exhibit A attached hereto and incorporated herein by reference) to include additional revenues and expenses as follows:

SECTION 3: That all resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of the conflict.
