

**RESOLUTION NO.\_\_\_\_\_**

**A RESOLUTION REPEALING RESOLUTION NO. 10861 WHICH CONDEMNED PROPERTY LOCATED AT 1605 NORTH CHANDLER IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS; AND FOR OTHER PURPOSES.**

WHEREAS, On June 24, 2024, the North Little Rock Council (“City Council”) passed Resolution No. 10861, whereby the structures at 1605 North Chandler (owned by First Commercial Mortgage Co.) was declared a nuisance and condemned; and

WHEREAS, Brian Banks purchased the property, and the structure has been demolished and the site cleared to the specification of the North Little Rock Municipal Code with all fines and fees satisfied (see letter attached hereto as Exhibit A).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That Resolution No. 10861, passed by the City Council on June 24, 2024, is hereby repealed, and the subsequent condemnation of 1605 North Chandler, are hereby repealed, said property being more particularly described as follows:

SOUTH 45' OF LOT 6, BLOCK 7 OF THE HOLT'S INDUSTRIAL ADDITION TO THE CITY OF NORTH LITTLE ROCK, PULASKI COUNTY, ARKANSAS, (PARCEL NO. 33N2570009900).
